## **1. Introduction**

The European Volleyball Confederation is pleased to open the registration procedure for the the CEV U18 Volleyball European Championship for both genders, going in line with the FIVB and CEV Board of Admistration decisions to align the U-age groups.

The Final Phase of the stated competions will be played with the 16 teams.

The organisation of the respective Final Phase have been granted as follows:

- Men U18 in BULGARIA in cities Sofia and Plovdiv on 10-21/07/2024
- Women U18 in Nicosia, CYPRUS and GREECE (venue tbc) on 01-13/07/2024

This Championship will be managed and processed through the CEV database and therefore we ask all National Federations to apply the necessary accuracy while working with it.

It remains the sole responsibility of the NFs to respect all Communications, CEV Volleyball Competitions Regulations, Guidelines, and institutional decisions to guarantee the delivery of correct, accurate and complete data at any time that these are required.

### 2. Registration procedure and deadline

The registration for this edition will be done through the CEV Database by using the CEV form 01CH (Team Registration).

The registration deadline for closing and sending the above-mentioned form is:

#### Friday September 15, 2023 at 23:59 CET

After closing the form on-line, National Federations must click 'Print Form' and then sign the paper copy and send it by registered letter to the CEV Office.

This must also be sent with a postmark dated on or before the above-mentioned deadline for the registration to be valid.

On this form there are tick boxes to inform CEV if the respective National Federation intends to apply to organise one of the 2<sup>nd</sup> Round qualification tournaments. However, the definitive application forms and required procedure for applying to organise a tournament will be sent to all NFs after the registrations are confirmed.

## 3. Age limit

According to the Official Regulations, the CEV U18 Volleyball European Championship 2024 edition will only be open to:

Female and respectively Male players that are:

Born on 1<sup>st</sup> January 2007 or thereafter

## 4. Competition format and dates

The 2024 competition will be structured and include Final phase and Qualification phase, the latter is covering the 1<sup>st</sup> and 2<sup>nd</sup> Round Qualifers as follows:

#### 1<sup>st</sup> Round Qualifiers (Zonal)

The 1<sup>st</sup> Round Qualifiers will be organised in each of the six CEV Zonal Associations. Following the registration, CEV will inform each about the exact number of National Federations from their respective zone who have registered for participation.

Moreover, further to a decision made by the CEV Board of Administration, a minimum of 40% of the respective National Federations have to register for participation in order for the zonal event to count as a 1<sup>st</sup> Round Qualifiers for the European Championship. <u>The host(s) of the Final Phase are not allowed to participate in the qualification process.</u>

If one or more Zonal Associations fail to fulfil this requirement, depending on the total number of teams registered for participation in the championship, their teams might:

- have to join those from another zone to compete in the first stage of the qualification process
- join a qualifying round including teams from different zones put together as per the results of a Drawing of Lots

Each Zonal Association shall organise their qualification stage according to the calendar set by CEV for this round starting earliest 01<sup>st</sup> October 2023 and ending before 31<sup>st</sup> January 2024.

In each tournament, the first placed team qualifies directly to the Final Phase from the respective Zone.

#### 2<sup>nd</sup> Round Qualifiers

The 2<sup>nd</sup> Round Qualifiers are organised with a maximum of 20 National Federations who competed but did not qualify from the 1<sup>st</sup> Round Qualifers to the Final Phase.

The number of the granted vacancies per Zone (quotas) in the 2<sup>nd</sup> Round Qualifers depends on the total number of the registered teams. The team quota per Zone to qualify to 2<sup>nd</sup> Round is based on the percentage of overall European Ranking points per Zone calculated based on participating teams and will be comunicated in the next Official Communications.

COMPETITION FORMAT:

- The 2<sup>nd</sup> Round Qualifers will be played using the single round robin tournaments format (i.e. one tournament "one against each other").
- Each 2<sup>nd</sup> Round Qulifiers will be played with minimum three and maximum four teams.
- The teams in each 2<sup>nd</sup> Round Qulifiers will play one tournament over three competitions days:
  - Tournament with 3 teams: each team will play 2 competition days
  - Tournament with 4 teams: each team will play 3 competition days
- Each of the National Federations involved has the right to apply for the organisation of the tournament.



- Should more than one National Federation apply for the organisation, the organisers will be drawn by the CEV. Or should no National Federation apply for the organisation, the organiser will be drawn by the CEV.
- In each pool, the first best placed team qualifies to the Final Phase. In case of a vacancy in the Final Phase, the next best placed team across all pools not qualifed yet, qualifies to the Final Phase.

#### Final Round Format:

Further to the expansion of the number of participating teams from 12 to 16, as per the relevant decision taken by the CEV Board of Administration, the 16 teams contesting the Final Round will be playing seven matches each in the pool stage according to the single round robin format (one against each other).

The first and second-ranked teams from each pool will progress to crossed-semi-finals, with the pool winners playing against the runners-up from the other group. Matches for the gold and bronze medals will follow on the final competition day as per the results of the semi-finals. All teams finishing from third down to eight in the pool phase will be returning home after the end of the group stage without contesting any other classification matches.

## 5. 1<sup>st</sup> Round Qualifiers - format and dates

Following the receipt of the confirmed list of registered teams, each Zonal Association must confirm to CEV their competition structure and dates <u>by Monday 02<sup>nd</sup> October 2023</u> regarding the 1<sup>st</sup> Round Qualifiers.

## 7. 2<sup>nd</sup> Round Qualifiers

Following the completion of the 1<sup>st</sup> Round Qualifiers, CEV will confirm the teams qualified to the 2<sup>nd</sup> Round. Those 2<sup>nd</sup> Round pools will be defined by the Serpentine System, once the 2<sup>nd</sup> Round organisers are known and seeded as head of those 2<sup>nd</sup> Round pools.

## 8. 2<sup>nd</sup> Round Qualifiers - organiser application

Forms to apply to organise 2<sup>nd</sup> Round tournaments will be sent to all participating teams in due time before 31<sup>st</sup> January 2024.

## 9. FIVB U19 World Championships

The FIVB will inform all NFs accordingly reagrding the calendar and Continental quotas for this event.

## 2. Vacancies 2nd Round

The 2<sup>nd</sup> Round is organized with participation of maximum 20 National Federations, whose teams have not managed to progress to the Final Round via the 1<sup>st</sup> Round qualifiers run by the respective Zonal Associations.

The winners of the zonal qualifiers organized by BVA, EEVZA, MEVZA, NEVZA and WEVZA will all claim a spot in the Final Round of the competition.

In the 2<sup>nd</sup> Round, National Federations are allocated to pools comprising of four teams. The five 2<sup>nd</sup> Round pool winners and four runners-up will all progress to the Final Round. In the men's U18 competition, pool winners and all runners-ups will progress to the Final Round.

For the first time in history, the respective Final Round European Championship will feature 16 teams in an effort to provide additional opportunities for young players to compete at the highest level on the European stage.

The number of vacancies per Zonal Association in the 2<sup>nd</sup> Round qualifiers reflects each Zone's contribution (%) to the total number of registered teams and their cumulative ranking points. Therefore, the vacancies per Zonal Association are as follows:

## 5. 2nd Round: Competition Accreditation cards

In line with the CEV Volleyball Competitions Regulations, each person accredited must receive an accreditation Card/ Badge. It is mandatory to use the CEV Accreditation System for all CEV competitions.

Only each tournament organiser is in charge of producing the badges for all participating teams in the respective pool and appointed CEV officials. Those can be extracted and synchronized directly from the database.

You can access the accreditation system via <u>this</u> link or via the National Federations Area of the CEV Database (<u>https://accreditation.cev.eu/login/cev</u>). Furthermore, there is a Badge Manager for the printing of the Badges for the matches. Each organiser is responsible for printing the badges for all teams participating in the respective tournament.

The guidelines on how to navigate through the software are available within the documents area in the accreditation system.

\*For the avoidance of doubt, although the "Betting & gambling services" sector and/or category is reserved by the CEV, the Organiser may exploit, based on prior agreement of the CEV, the category for the "National lottery", provided that their sports betting operations are in no way presented under the same brand as their National lottery operations. Thus, gambling and betting services are prohibited and the category will not be released by the CEV.

The CEV partner is the ultimate betting rights holder on a global basis in relation to the National team and Club competitions, including the CEV Volleyball U18 European Championships.

## 8. Final Round - Production Obligation & Broadcast Standards

In relation to the Final Round of the CEV Competition, the CEV is granting to the National Federations the non-exclusive domestic media rights in relation <u>only</u> to the matches organized by the National Federations in their host territory in exchange of the production of such matches in accordance with the CEV broadcasting standards indicated in *Section 7: Media Production* of the CEV Volleyball Competitions Regulations.

<u>There is no media rights reciprocity allowed</u> between participating National Federations to the CEV Competition.

The Organiser is allowed to stream the matches organized in its host territory on a live basis on its official digital platforms. Upon request of the CEV, the said platforms shall be geo-blocked (i.e. the streaming signal is only seen in the host territory).

The Organiser shall produce minimum a Streaming Feed signal for the following matches of the CEV competition:

• Semi-Finals 1-4, Bronze and Gold Medal matches (total of 4 matches)



The Streaming Feed shall consist of:

- A live uninterrupted and continuous HD TV signal 16:9
  - i. Video HDTV SMPTE 292 M HD IT-R BT 709 aspect ratio 16/9
- ii. Audio AES/EBU 48 kHz 20bit embedded
- Three (3) HD cameras (including one (1) fixed camera and two (2) hand-held)
- Official CEV English match data TV graphics to be integrated into the feed
- Audio configuration: international stereo sounds
- A feed with slow-motion and replays.
- Without any national or unilateral elements including but not limited to anchorman, stand-up positions, local advertising, interviews and national logos.


