## NATIONAL BEACH VOLLEYBALL CLUBS COMPETITIONS - REGISTRATION APPLICATION FORM



In order to homologate your National Beach Volleyball Clubs competition, this form must be sent via e-mail to CEV <u>beachclubs@cev.eu</u> by April 30<sup>th</sup> 2025.

The CEV, once approved, will send the form dully signed and sealed and will post the related information on its website.

## MINIMUM REQUIREMENTS

Enforced official FIVB Rules of the Game.

Exceptions as presented for the CEV Beach Volley European Cup Official Communication may apply.

Reporting of the competition stages, results and final standing of the National competition through the CEV Registration Application form and the CEV competition Management platform

At least three teams participating in the National Beach Volleyball Clubs Competition. The same Club may be represented by multiple entries (e.g. Club A I, Club A II, Club B I, Club B II etc...)

Representation of each Club by minimum 4 athletes and competition format of minimum 2 teams in each Club vs Club match is compulsory.

Players participating in the National Beach Volley Clubs competition must hold a national licence issued by the National Federation by which the Player and the Club are associated for the specific season determined under the conditions defined by the National Federation.

Prize Money is recommended but not compulsory.

FIVB homologated ball. CEV will be allocating MIKASA balls to all homologated National Beach Volleyball Clubs competitions with the precondition that those are used for the competition.

Post event report to be sent to the CEV Beach Volleyball Department (<u>beachclubs@cev.eu</u>) on the first working day after completion of the competition, including results, final standing and pictures.

## **Important Notes**

- The winner of the National Beach Volley Clubs competition will qualify to the CEV Beach Volley European Cup. Should the winner waives this right, the spot may be allocated by the NF to the next best ranked club wishing to participate upon CEV approval.
- For the 2025 edition a 2<sup>nd</sup> spot to the CEV Beach Volley European Cup will be allocated to the top 4 National Federations in the CEV BV European Cup NF Ranking.
- > Should the winner or runner up for the top 4 National Federations waives this right, the spot may be allocated by the respective NF to the next best ranked club wishing to participate.
- Registration to the CEV Beach Volley European Cup follows the provisions of the CEV Beach Volley European Cup Official Communications. Club(s) registered to the will receive by the CEV authorisation to upload to the CEV platforms all requested data within the set by the Official Communication deadlines.
- No FIVB Ranking points will be allocated through the National BV Clubs Competition.
- For the international players' participation in a National Tour, the hosting and participating National Federations are required to abide by the FIVB Sports Regulations and in particular:
  - a. Only registered athletes being in good standing with the FIVB and with the respective NF may take part in a National Beach Volleyball Clubs competition.
  - b. International players' participation should be agreed between the hosting NF and the NF of Origin, with written endorsement issued by their NF.
