| Reporting of the competition stages, results and final standing of the National competition through the CEV Registration Application form and the CEV competition Management platform |
| Representation of each Clubs by minimum 4 athletes and competition format of minimum 2 teams in each Club vs Club match is compulsory. |
| Players participating in the National Beach Volley Clubs competition need to hold a national licence issued by the National Federation by which the Player and the Club are associated for the specific season determined under the conditions defined by the National Federation. |
| Prize Money is Recommended but not compulsory |
| Homologated by the FIVB ball. CEV will be allocating MIKASA balls to all homologated National Beach Volleyball Clubs competitions with the precondition that those are used for the competition |

Important Notes

- The winner of the National Beach Volley Clubs competition will qualify to the CEV Beach Volley European Cup. Should the winner waives this right, the spot may be allocated by the NF to the next best ranked club wishing to participate upon CEV approval.
- The CEV may allocate additional spots to the applying National Federations, based on participation and event promotion criteria. The CEV remains the final decision maker concerning the allocation of spots per National Federations
- The respective Club(s) will receive by the CEV authorisation to upload to the CEV platforms all requested data within the set by the Official Communication deadlines
- No FIVB Ranking points will be allocated.
- For the international players' participation in National Tour, the hosting and participating National Federations are required to abide by the FIVB Sports Regulations and in particular:
 - a. Only registered athletes being in good standing with the FIVB and with the respective NF may take part in a National Beach Volleyball Clubs competition.
 - b. International players' participation should be agreed between the hosting NF and the NF of Origin, with written endorsement issued by their NF.




