1. Introduction

The European Volleyball Confederation is pleased to open the registration for the 3rd edition of the CEV U22 Women / U22 Men Volleyball European Championships, with qualifiers due to take place in 2025 and the Final Phase to follow in the summer of 2026.

The Final Phase scheduled for 2026 will be taking place as follows (exact dates will be shared in due time):

- Women between 06 and 12/07/2026 (TBC) in The Netherlands
- Men between 29/06 and 12/07/2026 (TBC) organiser pending (TBD)

The Final Phase will feature eight teams in each gender – as it was played since the first edition of the latter championships organised in 2022.

The format of the respective qualifiers depends on the total number of registered teams. A maximum of four teams will be playing in the same qualifying pool, with the number of pools to be confirmed after the end of the registration process depending on the total number of registered teams.

The latest ranking for the U22 Men and U22 Women age groups will be taken into account to define the pool composition in the qualifiers.

It remains the sole responsibility of the NFs to respect all Communications, Regulations, Guidelines, and any other institutional decisions to guarantee the delivery of correct, accurate and complete data at any time that these are required.

2. Age Limit

Based on the relevant CEV Board of Administration decision, the CEV U22 Volleyball European Championships 2026 (Women/Men) will be open to:

Female and Male players (U22):

Born on 1st January 2005 or thereafter

Please note that athletes of National Federations from Categories 4 & 5 can only participate in two agegroup competitions (including senior) per year.



3. Registration procedure and deadline

The registration for this edition will be done through the CEV Database using the following form:

The registration deadline for closing and sending the above-mentioned form is set for:

After closing the form on-line, National Federations must click 'Print Form' and then sign and stamp the paper copy and send it by post to the CEV Office.

On this form, there are tick boxes to inform CEV if the respective National Federation intends to apply to organise one of the qualification tournaments (though a separate application form needs to be sent to CEV).

4. The Competition Window

As previously mentioned in this very same document, the format and number of teams involved in the qualification process depends on the total number of registered teams.

The teams representing the host countries of the Final Phase – the Netherlands for U22 Women and for the still pending organiser of the U22 Men – are automatically qualified for the Final Phase of the competition. This means that seven spots will be at stake in the summer of 2025 to qualify for the final stage of the championship.



2. Final Round organisers and dates

The respective Final Round Tournament Organisers and competition dates are confirmed as follows, after the communication no. 1 was released:

3. Qualification Phase format and dates

The 2026 competition will be structured as follows:

Teams are allocated according to the latest CEV European Ranking in the respective age category (as of July 2024) and the serpentine system. The organisers of the qualification tournaments are seeded as head of their pool. The teams having no ranking position previously were drawn into the respective pools, same was applied if teams are sharing the same Ranking position with no other possibility to break the tie.

The qualification dates are as announced through the Official Communication no. 1, so qualifiers will be played as follows:

Qualification phase

The Qualification Phase will be played using the single round robin tournament format (i.e. 1 tournament "one against each other"), with 7 (seven) teams qualifying from the Qualification Round to the Final Round where they will join the respective organiser.

COMPETITION FORMAT:

- Each Qualification tournament will be played with minimum 3 [three] and maximum 4 [four] teams (*).
- In the U22 men's competition, based on the number of registered teams, 5 Pools will be organised (all pools with 4 teams). (*)
- In the U22 women's competition, based on the number of registered teams, 5 pools will be organised (3 pools with 4 teams and 2 pools with 3 teams). (*)
- When 4 [four] teams are in a Qualification Pool, teams will play 1 [one] tournament (3 competition days with 2 matches per day = single round robin). (*)
- When 3 [three] teams are in a Qualification Pool, teams will play 1 [one] tournament (3 competition days with 1 match per day = single round robin). (*)
- In each pool, the first placed team qualifies to the Final round and the remaining places will be filled by the next best ranked team(s) across all pools, i.e. the two best second placed teams will progress to the Final Round as well.

(*) To define the best second-ranked teams across all pools when pools feature a different number of teams, the CEV will discard the results of the matches played with the lowest placed team in the pools of four to compare the performance of all runners-up based on the same number of matches.



4. Final Round format and dates

The 2026 competition Finals will be structured as follows:

The Final Round will be organised with eight teams. The team of the host country is directly qualified to the Finals and will be joined by the best 7 teams coming from the qualifications. In the men's and women's U22 competition, the five pool winners and the two second-placed teams with the best result across all pools will progress from the qualifiers to the Final Round.

The Final Round will be played with two pools of four teams each (single round robin), the two best placed teams from each pool will continue to the semifinals and all remaining teams will leave the tournament. On the final day, the bronze and gold medal matches will take place.

The competition requires six competition days (that includes 1 rest day between the end of the pool phase and the semifinals). The teams arrival is as usual -2 days before the first competition day and departure is either the day after the end of the pool phase or after the medal matches if a team has qualified to the semis and medal matches. Maximum stay period is 9 days (including arrival and departure days).


