## 1. INTRODUCTION

This Official Communication No. 1 (Registration) supports all National Federations interested in registering teams for one of the CEV Clubs competitions.

It contains important information and explanations about registration, regulations, and other items to ensure a smooth running of the competitions.

You will find a useful timeline / to-do-list in the [Organisation Guidelines - Chapter 1](#) available on the CEV website. Please read it carefully.

The CEV Office is available to help, should you have any questions, or need any assistance during this process.

## 2. 2025 REGISTRATION PROCEDURE

Registration is done via the CEV database by completing the 01 form (one per gender), no later than:

**Friday 21 June 2024 at 12:00 CEST.**

Once you close the 01 form, the data is recorded and cannot be changed anymore. The CEV will set the form as 'Accepted' as soon as it is checked. When the signed and stamped originals sent by mail are received, the CEV will set the form as 'Confirmed'.

## 3. ALLOCATION OF SLOTS

The allocation of slots per National Federation reflects the [CEV European Cups 2025](#) Ranking List.

Given that Russian and Belarusian teams are not eligible to register for participation in the CEV European Cups 2025, further to a decision made by the CEV Board of Administration which still stands, the vacant positions in the 4th Round of the CEV Champions League Volley will be allocated according to results achieved on the court and by moving up the next best-ranked National Federations in accordance with the CEV European Cups Ranking List 2025 as follows:

- MEN
  - GER increases from 2 to 3 slots.
  - FRA increases from 1 to 2 slots.
  - SLO promoted from 1-3 Rounds to 4th Round, with one slot in the 4th Round.
  
- WOMEN
  - \*UKR increases from 1 to 2 slots.

- HUN promoted from 1-3 Rounds to 4th Round, with one slot in the 4th Round.
- SLO promoted from 1-3 Rounds to 4th Round, with one slot in the 4th Round.

\* According to the CEV Volleyball Competition Regulation art.161, as the National Federation of UKR did not apply for the registration of the allocated slot in the 4<sup>th</sup> Round of the CEV Champions League Volley 2024. Consequently, the National Federation of UKR loses one (1) of the two (2) allocated slot. Therefore, the National Federation of UKR is allocated with one (1) slot in the 4<sup>th</sup> Round and the National Federation of SLO is promoted from 1-3 Rounds to 4th Round, with one slot in the 4th Round.

By increasing the slots in the CEV Champions League Volley 4<sup>th</sup> Round as per the provisions listed above, the remaining slots for the CEV European Cups competitions will be adjusted accordingly in accordance with the CEV European Cups 2025 Ranking List.

According to the CEV Volleyball Competition Regulations Article 31.1 §1, The CEV only registers a maximum number of Clubs per gender and per National Federation, as follows:

- a) 5 in all Clubs competitions
- b) 3 in the CEV Champions League Volley

The winning Club of a CEV Zonal Association Cup is not considered in the calculation of the maximum number of Participants for each and all Club competitions.

Any CEV Zonal Association Cup shall be finalised:

- Men & Women until 22 September 2024

The CEV Zonal Associations are kindly requested to inform CEV no later than **Friday 05 July 2024 at 23:59 CEST** to confirm the teams participating in their Zonal Cup – if any such competition is organised. The event shall feature a minimum of four teams per gender representing four different countries.

## **4. CEV REGULATORY FRAMEWORK**

During your participation in a CEV competition, you will have to use and comply with the CEV Regulatory Framework, mainly with the CEV Volleyball Competitions Regulations, Guidelines, and the Official Communications. These documents are available on the dedicated section of the CEV website: <https://inside.cev.eu/documents/volleyball-documents/>

You will also have to fill in CEV forms. These forms are available in your area in the CEV database.

For a full list of the CEV forms, please check the Organisation Guidelines - Chapter 2.

The CEV Board of Administration approved new changes to the CEV Volleyball Competitions Regulations. The latest version of such regulations is available on the CEV website.

**Please be aware that by registering for the CEV European Cups 2025, you acknowledge that you have read and agreed on the terms of these Regulations and Official Communication.**

## 5. 2025 CEV EUROPEAN CUPS CALENDAR

The 2025 European Cups calendar is currently available in your download area in the CEV database.

## 6. CEV EUROPEAN CUPS 2025 COMPETITION SYSTEM

Due to a recent FIVB decision on the international calendar, the CEV is considering adapting the competition system of the CEV Champions League Volley Final phase. This includes the potential change to the Final Four format.

The CEV Board of Administration will decide on this new competition format during their meeting that will take place 15/06/2024 in Jurmala (LAT).

Afterwards, CEV will communicate the confirmed competition system of the CEV Champions League Volley, CEV Volleyball Cup and CEV Volleyball Challenge Cup prior to registration deadline.

The CEV European Cups 2025 Drawing of Lots event will be live streamed on the official CEV YouTube & Facebook channels.

## 12. USE OF LED SYSTEM

### **CEV Champions League Volley:**

The use of the LED system is mandatory from the 4<sup>th</sup> Round of the CEV Champions League Volley.

The clubs shall submit the “LED system application form” to the CEV for approval no later than 4 weeks before the start of the 4<sup>th</sup> Round.

### **CEV Volleyball Cup:**

The static banner system is allowed up to the ¼ Finals, and the LED system is mandatory starting from the ½ finals.

The clubs shall submit the “LED system application form” to the CEV for approval no later than 4 weeks before the start of the competition.

### **CEV Volleyball Challenge Cup:**

The static banner system is allowed up to the ¼ Finals, and the LED system is mandatory starting from the ½ finals.

The clubs shall submit the “LED system application form” to the CEV for approval no later than 4 weeks before the start of the competition.

The LED system application form is available on the CEV Cloud (download area).  
The application form must be submitted as specified in the application document.

## **13. COMMERCIAL RIGHTS**

In accordance with the rights already granted to Clubs (Chapter 18 of the CEV Volleyball Competitions Regulations), the table hereafter shows the split of Advertising spaces on the Playing area between the CEV and the organising clubs.

\*\* Static banners are only allowed from 1<sup>st</sup> – 3<sup>rd</sup> Rounds in the CEV Champions League.

In case no CEV partner is contracted by 30 September 2024 (date due to prior contractual commitments of CEV), 10% of the CEVs LED timing will be ceded to the clubs.

If not used, the CEV may release one or more of the above-mentioned categories by 30 September 2024 at the latest (date due to prior contractual commitments of CEV). In any case, the categories “Sports Equipment – Volleyballs” will not be released.

\*For the avoidance of doubt, although the “Betting & gambling services” sector and/or category is reserved by the CEV, the Organiser may exploit, based on prior agreement of the CEV, the category for the “National lottery”, provided that their sports betting operations are in no way presented under the same brand as their National lottery operations.

## **14. BRANDING**

For the upcoming season, all branding materials and layouts will be made available in due time after registration in the Download area on the CEV Cloud and need to be implemented by all the clubs for the season 2024/2025.

Further information on all graphics will be published in the next Official Communication.

## **15. MATCH TECHNOLOGY**

For each match, the following match technologies are provided and their use by the participating Club is mandatory for the CEV European Cups 2025:

- e-Scoresheet;
- e-Scoresheet Tablet;
- Data Volley 4;
- Video Sharing.

The applications are provided by CEV’s official technology partner Genius Sports. The applications download and user guidelines documentation link is the following:

Please find here below more information related to the usage of the e-Scoresheet, e-Scoresheet Tablet, Data Volley 4 and Video Sharing software. The software should be operated by following the official CEV Volleyball Competition Regulations and the Genius Sport software's user guidelines documentation:

- e-Scoresheet is the only official software, operated by one (1) Scorer who officially records the match progress, results, participants, events, protests, and sanctions of such match. Statistics of each match are collected by designated match officials of the Organiser (or home team) for CEV purposes.
- The e-Scoresheet Tablet is the part of the e-Scoresheet software operated by a team bench and match referees to manage match line-ups, substitutions, timeouts, video challenges, and to follow player positions.
- **Data Volley 4** is the only official software, operated by one (1) Statistician who officially records players and team's statistics of each match. The statistics of each match are collected by a designated Statistician of the Organiser for CEV purposes.
- Video Sharing is a software operated by a designated Statistician to upload and download match video recordings and statistics collected by Data Volley 4.
- CEV provides the necessary log-in credentials (including username & password) for the above software to the Organiser prior to the start of the CEV Competition.

The Organiser must provide free-of-charge the following facilities and resources during the CEV Competition to operate the e-Scoresheet, e-Scoresheet Tablet, **Data Volley 4** and Video Sharing in a professional manner:

- Hardware including laptops or tablets that meets the software's minimum technical requirements.
- Download and installation of the latest version of the software.
- High-speed and stable internet connection for e-Scoresheet and Data Volley 4 via LAN cable with at least 10 Mb/s up and down speed and necessary power supply during the CEV Competition to ensure professional data collection and distribution to CEV and all CEV Commercial partners.
- Appointment of an experienced Scorer and Statistician during the CEV Competition to operate the software applications and collect data and statistics according to the respective regulations.
- Execute e-Scoresheet and **Data Volley 4** match tests in the Competition Hall one (1) day before the start of the match scheduled for a CEV competition.
- Delivery of e-Scoresheet and Data Volley 4 live match statistics with no internet connection interruptions and data collection mistakes during the CEV Competition match using the credentials provided by the CEV.
- Prohibition of any illegal or non-authorized collection, archiving and distribution of match related data and statistics during all matches.

Wireless headsets and microphones for referees, and Challenge System technology are mandatory and optional in different phases of CEV Competitions. More information is available in the CEV Volleyball Competitions Regulations – Chapter 15.

The CEV is the ultimate media rights-holder of the CEV Club Competitions including the CEV Champions League Volley, the CEV Volleyball Cup and the CEV Volleyball Challenge Cup. The CEV has appointed the Sport Media Agency Infront as its exclusive global media rights distribution partner for the above-mentioned competitions.

The following media rights range of exclusivity and broadcasting standards which are duly stated in the CEV Volleyball Competitions Regulations will apply during the CEV European Cups season 2024/2025:

### 1. CEV Champions League Volley

#### Match Schedule

In relation to their home matches, it is the responsibility of each participating club to submit officially their match date & starting time (in local time) proposals to the CEV via the 07 form.

Once submitted by the club, the proposals are considered definitive and reviewed by the CEV and the CEV Sport Media Agency. In case their competition hall is not available during the set competition window, the participating clubs shall inform the CEV via email before closing the said form.

Similarly, the participating clubs sharing competition halls/venues shall coordinate between each other before submitting their proposals via the 07 form (such clubs might also request the support of their National Federation to help in the coordination).

The CEV and the CEV Sport Media Agency reserve the right to select any of the submitted proposals by the participating clubs and confirm the final match schedule (in accordance with art. 13.3. of the official CEV Volleyball Competitions Regulations).

#### Media Rights

On behalf of the CEV, the CEV Sport Media Agency Infront is managing and distributing the exclusive worldwide media rights with respect to the Men & Women CEV Champions League Volley. As a result, the participating clubs **do not hold** any media rights in their domestic territory.

In order to ensure a professional broadcast production, the participating clubs must provide upon request to CEV and its Sport Media Agency the following facilities and services on a free-of-charge basis:

- Camera platforms for one (1) or two (2) cameras centralised above the court and at the appropriate angle to produce a TV signal of international standard.
- A minimum number of commentary positions for each match to be located on the same side of the main camera and as close as possible to the field of play.

- Access to match data/statistics for the host broadcaster and the TV graphic operator.
- Adequate space in the TV and SNG compound for TV transmissions and production vans.
- One (1) fully furnished office for the CEV Sport Media Agency team on-site.
- Support to access the venue, TV compound and other broadcast areas.

In case the CEV and the CEV Sport Media are not able to close a media rights license agreement and find a host broadcaster in the Host Country of the Organiser, the Organiser will have to contribute to the cost of the production and delivery of a World Feed signal for its domestic matches.

## 2. CEV Volleyball Cup & CEV Volleyball Challenge Cup

### Media Rights

With respect to the domestic matches only, the CEV is granting to the Participating Clubs the non-exclusive domestic media rights in the territory.

### Host Broadcast Production

The participating clubs shall respect and fulfil the requirements stated in the CEV Volleyball Competitions Regulations and indicated below:

For the avoidance of doubt, any domestic matches produced by the Participating Clubs during the CEV Volleyball Cup and CEV Volleyball Challenge Cup shall respect the following World Feed signal format and signal delivery requirements:

Quality	Live uninterrupted & continuous HD 1080i 50Hz 16:9 World Feed signal
Audio configuration	Minimum four (4) audio channels for international stereo sounds and 2 <sup>nd</sup> language commentary mix (if applicable)
Microphones	Min. six (6) including one (1) net microphone to capture atmospherics
Signal Delivery	Established European satellite (Eutelsat 10A or 7B)
TV graphics	Provided by the CEV and its Sport Media Agency (via FTP)

For the avoidance of doubt, the World Feed signal of each produced match must be delivered to the CEV and its Sport Media Agency free of charge via satellite according to the following standards:

- Uplink to an established European satellite
- Book the corresponding satellite space (including the end-to-end test synopsis)
- Provide an encrypted satellite feed (also called BISS code)

In order to ensure a professional broadcast production, the participating clubs must provide upon request to the CEV and its Sport Media Agency the following facilities and services on a free-of-charge basis:

- Camera platforms for one (1) or two (2) cameras centralised above the court and at the appropriate angle to produce a TV signal of international standard.
- A minimum number of commentary positions for each match to be located on the same side of the main camera and as close as possible to the field of play.
- Access to match data/statistics for the host broadcaster and the TV graphic operator.
- Adequate space in the TV and SNG compound for TV transmissions and production vans.
- One (1) fully furnished office for the CEV Sport Media Agency media and production team.
- Accommodation (full board) – up to 2 rooms for the CEV Sport Media Agency staff on-site provided that they are requested minimum 2 months before the start of each match.

Lastly, comprehensive TV production manuals and on-screen graphics package will also be distributed to each participating club and appointed host broadcasters.

## 17. DIGITAL & SOCIAL COVERAGE

The rising of mobile phone users and social media changed the way we look at the sport of Volleyball including our engagement to that unique sport. There are many different social media platforms like Facebook, Twitter, Instagram, TikTok, and YouTube. Fans worldwide can use these social media platforms conveniently in their daily lives. Social media has also become an important tool for promoting events, distributing content, attracting new readers, and creating more engagement to teams and athletes.

The participating clubs should use social media to promote the CEV Clubs competitions. You may find below industry standards as well as social media tips that can be used throughout the season:

- Go “behind the scenes.” Make fans who are not at the event feel like they are there (and want to attend next time) by showing the scene on social media accounts. (e.g. show what the players are doing in their off time, before the game, etc.).
- Quote players: people love sharing a great quote. Make sure you use quotation marks and attribute it to the speaker.
- Think quality not quantity.
- Interaction between fans and athletes: when you post an interesting fact about a player, tag the athlete.
- Cross-post to other media. Make posts by attaching photos and videos of the event.

- Interact with people at the event. Share newsworthy posts by fans and credible sports journalists.

Participating clubs are also expected to engage and support the CEV Digital & TV Department with the following actions:

- Promote the events via their own social media channels on a regular basis.
- Use the official competition hashtags whenever posting about it.
- Access and use CEV Social Media Graphics creator platform
- Share on their social media behind-the-scene photos and video footage, showing the social side of players and staff, which can be re-tweeted or shared further on by the CEV.
- Provide the CEV with additional content to distribute on social media: the best promotion comes from the players themselves.
- Produce additional video material, such as mixed zone interviews in English, for publishing across social media channels.
- Engage with the CEV and other participating clubs on social media by liking, sharing, reposting, following, retweeting content.

## 18. TEAMS & PLAYERS PICTURES

### General Information

Team and athletes' pictures are used by the CEV for promotional purposes on its website, social media, TV graphics operations as well as to enhance the event experience for in-venue spectators with entertaining sport presentation concepts.

It is the responsibility of each participating club to provide quality pictures to the CEV based on the following requirements:

Athlete portrait shot & staff

A **portrait shot** of each registered athlete and key staff shall be provided as per the standard below:



Quality standards:

- Background: neutral – white only
- Eyes: facing the camera
- Expression: smiling
- Hands: behind the back
- Body position: straight to the camera with shoulder visible
- Match jersey: only from the current season (no training suit, national team jersey or polo shirts are allowed)

Each team registered will receive as usual 30 V200W-CEV or 15 V200W balls (depending on the competition) as material support from CEV. The balls will be sent by Mikasa to the respective National Federation in September 2024, then the National Federations will be responsible for dispatching the balls to their clubs participating in the European Cups 2025.

## 20. FLOORING

In all phases of the CEV Champions League Volley, it is mandatory to use a synthetic surface floor with 3-colour (Free zone: 6431-Teal, Back zone: 6146-Coral and Front zone: 6038-Terracotta) placed on wooden or equally appropriate sub-floor.

# 1. CEV European Cups 2025 Competition System

Due to a recent FIVB decision accounting for changes to the international calendar and further to the CEV Board of Administration Meeting held in Jurmala (LAT) on 15/06/2024, the CEV decided to amend the competition system for the 2025 edition of the CEV Champions League Volley.

The decision has been made to play the Final phase of the CEV Champions League Volley 2025 with a Final Four format in each gender. This stage of the competition will include the two semi-finals and a title-deciding match involving the winners of the semis. No match for the third place will be contested between the losers of the semi-finals.

Further to these changes, the Competition system for the CEV European Cups 2025 reads as follows:

## 2. CEV Champions League Competition System – Early Rounds Update

Further to the Official Communication N°2 art. 1, the CEV Champions League Volley Early Rounds 2025 will be played as follows:

### MEN:

- With seventeen (17) teams registered for the CEV Champions League Volley Early Rounds Men, a Preliminary round will be played with the three (3) lowest ranked teams among all registered teams. The Preliminary round will be played as a tournament with a single round robin format. The two (2) best ranked teams will qualify for the CEV Champions League Volley 1<sup>st</sup> Round.
- The CEV Champions League Volley 1<sup>st</sup> – 3<sup>rd</sup> rounds will be played as Home & Away matches and the two winning teams from the 3<sup>rd</sup> Round will qualify to the CEV Champions League Volley 4<sup>th</sup> Round Men.

The distribution of costs related to the organisation of the CEV Champions Volley 2025 Preliminary Round Tournament is as follows:

- Transportation:
  - Each participating team shall cover the cost of their own international transportation.
  - The organiser shall cover the local transportation.
- Accommodation:
  - Each participating team shall cover their own accommodation.
  - The organizer shall cover the accommodation of the CEV officials and match officials according to the CEV Volleyball Competition Regulations.
- TV production:
  - The production of the matches is the responsibility of CEV and the CEV Sport Media Agency. A 50% contribution to the TV production costs will be requested from the appointed tournament Organiser.
- Per Diem:
  - The organiser shall cover the costs of the per diem for the CEV officials and match officials.

In the CEV Champions League Volley Preliminary Round, the arrival date of the CEV Supervisor is 1 day before the tournament before 15:00.

The dates of the CEV Champions League Volley Early Rounds Men are as follows:

- Preliminary Round Men: 10-12/09/2024
- 1<sup>st</sup> Round Men: 17-19/09/2024 & 24-26/09/2024
- 2<sup>nd</sup> Round Men: 01-03/10/2024 & 08-10/10/2024
- 3<sup>rd</sup> Round Men: 15-17/10/2024 & 22-24/10/2024

### WOMEN:

- With ten (10) teams registered for the CEV Champions League Volley Early Rounds Women, the matches will be played in a Home & Away format. All the participating teams will start from the 3<sup>rd</sup> Round. The five (5) winning teams will qualify to the CEV Champions League Volley 4<sup>th</sup> Round.

The dates of the CEV Champions League Volley 3<sup>rd</sup> Round Women are as follows:

- 3<sup>rd</sup> Round Women: 01-03/10/2024 & 08-10/10/2024

## 5. Appointment of Challenge Referees

According to a decision made by the CEV Board of Administration in the meeting held 16 September 2023 in Rome, please be informed that the European Refereeing Commission (ERC) will appoint:

- Challenge Referees starting from the quarterfinal matches of the CEV Champions League Volley 2025
- Challenge Referees starting from the quarterfinal matches of the CEV Volleyball Cup 2025
- Challenge Referees for the final matches (home and away) of the CEV Volleyball Challenge Cup 2025.

As per the usual procedure, once confirmed, all nominations will be made available through the CEV Database. Clubs will be responsible for making the necessary arrangements (travel, accommodation and per diem) for the appointed Challenge Referees.

## 6. Media Rights & Production

As validated by the CEV Board of Administration meeting held in Jurmala (LAT) on 15<sup>th</sup> June 2024, we kindly would like to re-emphasize that a 50% contribution to the TV production costs will be requested to the participating Clubs of the CEV Champions League Volley in case no domestic broadcaster could cover it during the season.

## 2. Application for LED system

**As a reminder, using the LED system is mandatory as from the Champions League 4<sup>th</sup> Round.**

All teams shall download the LED system application form from the CEV Cloud <https://cloud.cev.eu/url/ledapplform20> and upload the compiled form into the club's relevant folder.

The fully compiled form must be sent electronically to CEV for approval:

- For 1<sup>st</sup> –3<sup>rd</sup> rounds, if applicable, by **Monday 19<sup>th</sup> August 2024**
- For 4<sup>th</sup> round by **Monday 7<sup>th</sup> October 2024**

The official LED playlist will be provided by CEV and be made available in the Download area of the CEV Cloud.

## 3. Team Uniforms & Advertising

When ordering team uniforms, clubs must make sure they are produced according to the FIVB Official Volleyball Rules and the latest version of the CEV Volleyball Competitions Regulations.

### 1. SPONSOR APPROVAL:

All sponsors shall be approved by CEV through the CLS form.

Please clearly indicate in the CLS form which of the sponsors appear on the uniform.

### 2. NON-APPROVED ADVERTISING

When taking part in the CEV Champions League, a team member may not carry any advertising material other than the name of the sponsors which have been registered by his team in the CLS form and which have been approved.

For the sake of clarity, permanent and temporary tattoos may not display any advertising material and shall be covered when in a competition.

All teams are requested to proceed as follows:

### 3. TEAM UNIFORM APPROVAL:

Any approval of team uniforms shall only be valid if all sponsors are uploaded and approved in the CLS form.

After approval of the sponsors through the CLS form, teams are required to upload the layout in colour of their two sets of uniforms, shirts and shorts, with a front side and back side view into their club folder created on the CEV Cloud.

The CEV must be notified of the upload by sending a short email to [graphics@cev.eu](mailto:graphics@cev.eu).

N.B.: The uniform may be approved separately in case the production of the latter is launched before the activation of the CLS form in the [CEV database](#).

### 4. MANUFACTURER LOGO

The logo of the manufacturer is authorised on the team uniform, including jersey, shirt, shorts, jacket and socks, so long as it does not exceed 30 cm<sup>2</sup> or 6 cm x 5 cm on each item.

### 5. COMPETITION LOGO BADGE:

The CEV Champions League Volley 2025 logo must be on the team jersey as from the first match, namely on the right sleeve for jerseys with sleeves or on the upper right chest for jerseys without sleeves (see layout hereafter).

Teams shall download the new competition logo from the CEV Cloud and integrate the competition logo during the production of the jerseys.

The dimensions of the competition logo badge are as follows: 70 x 79 mm (width x height). Each team is responsible for integrating the competition logo badge on the jersey.

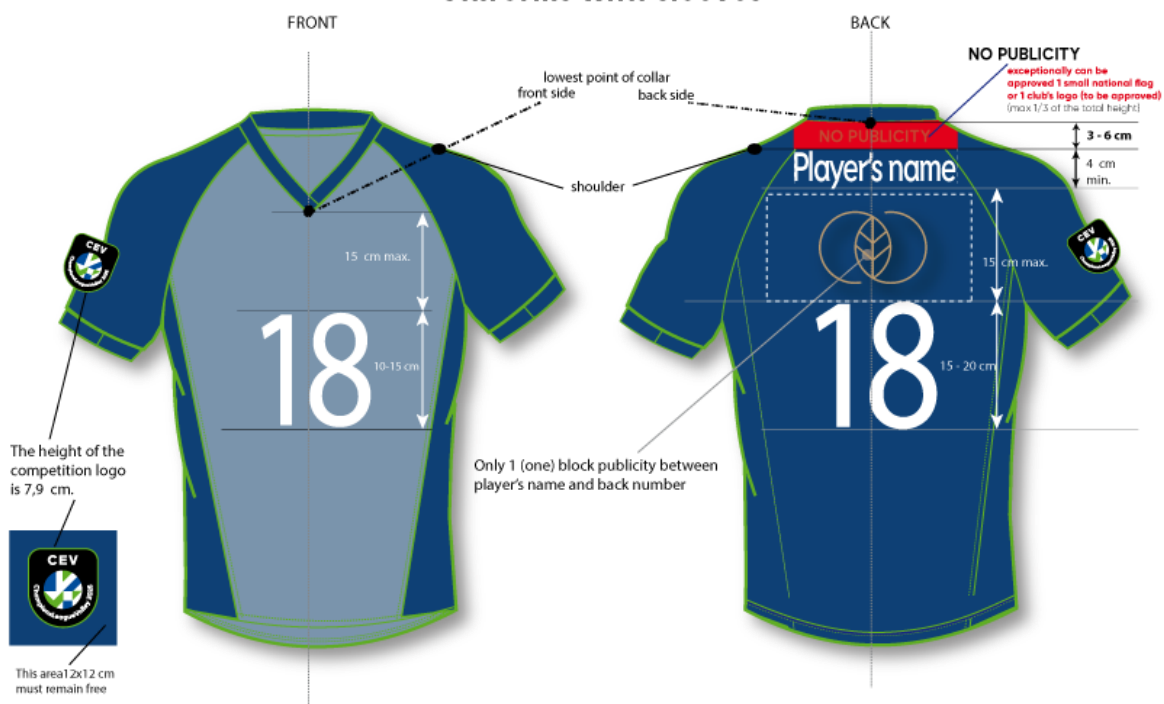

**All Rounds:**

According to the CEV Volleyball Competitions Regulations and Champions League Volleyball Brand Guidelines, all clubs participating in the CEV Champions League Volley 2025 are requested to respect the court layout as per the conditions displayed hereafter.

All **floor stickers** must be produced with an identical approach and style. Identical style means, if possible, a similar background for floor stickers F1 and F6 (recommended are transparent or darker backgrounds). Floor stickers with white backgrounds should be avoided.

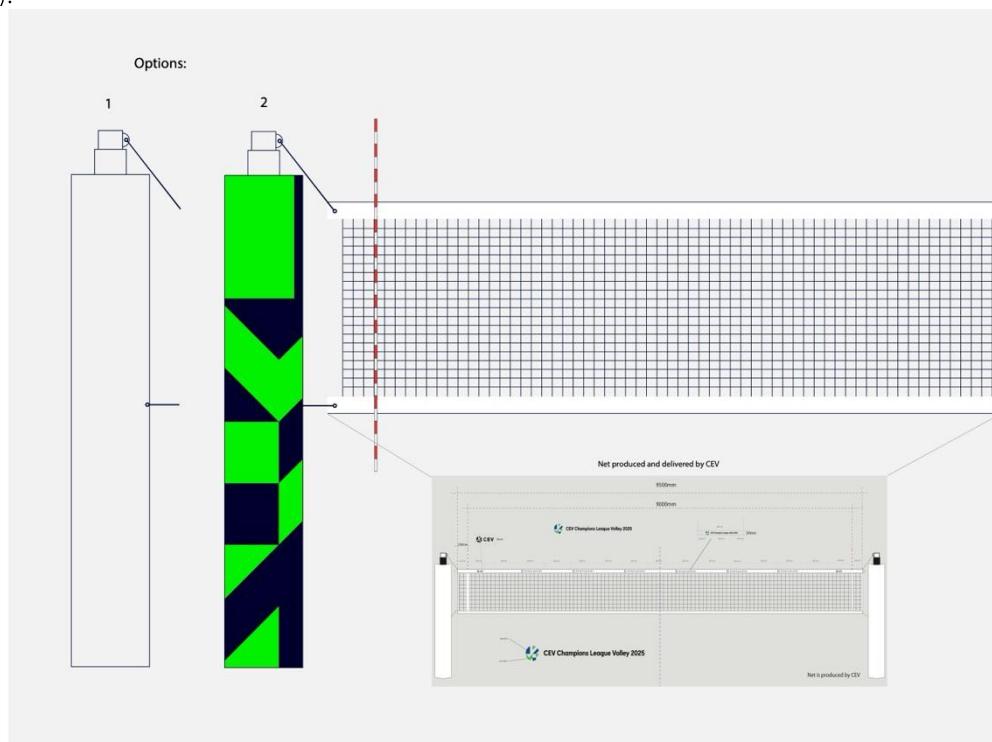

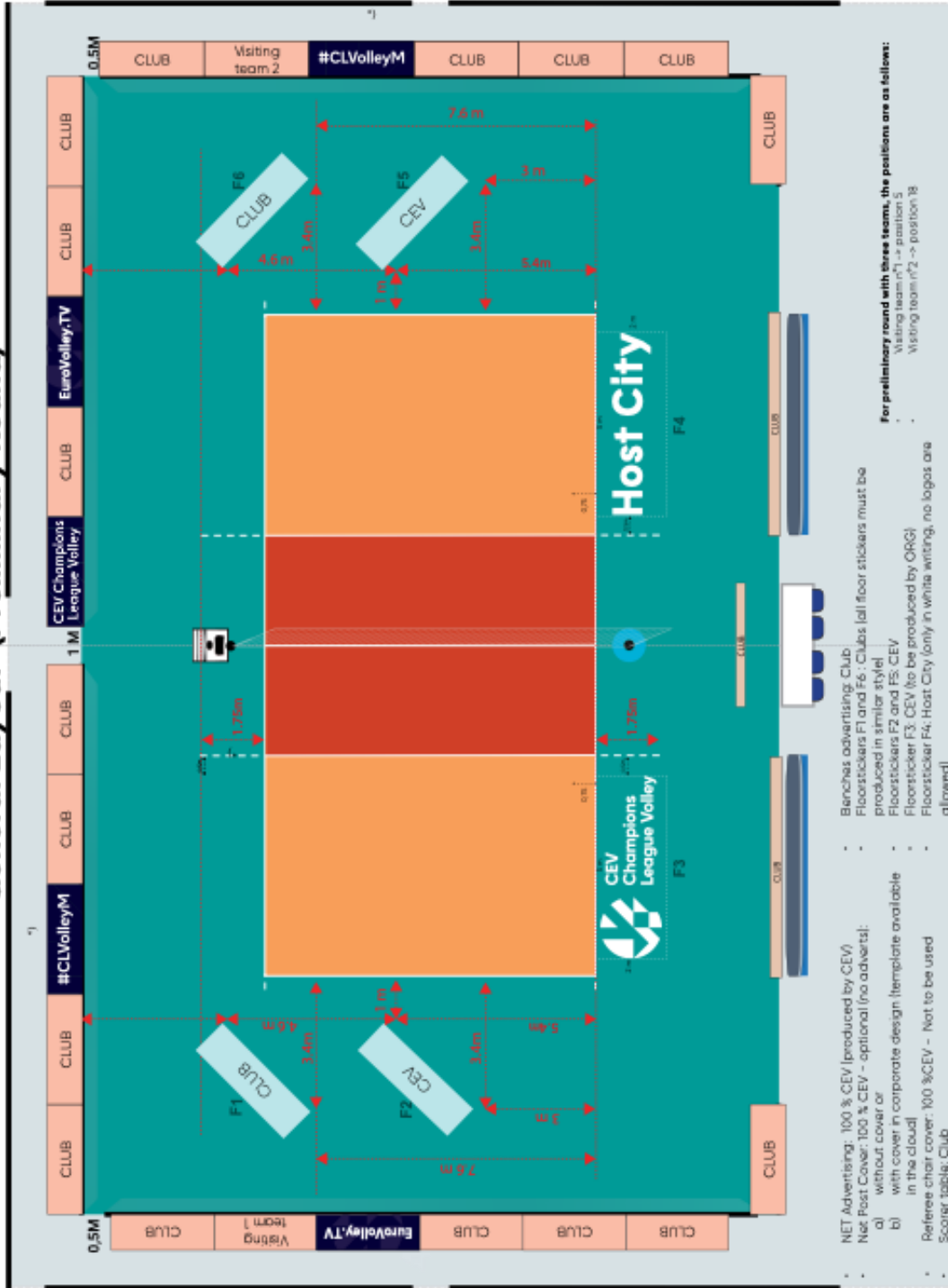

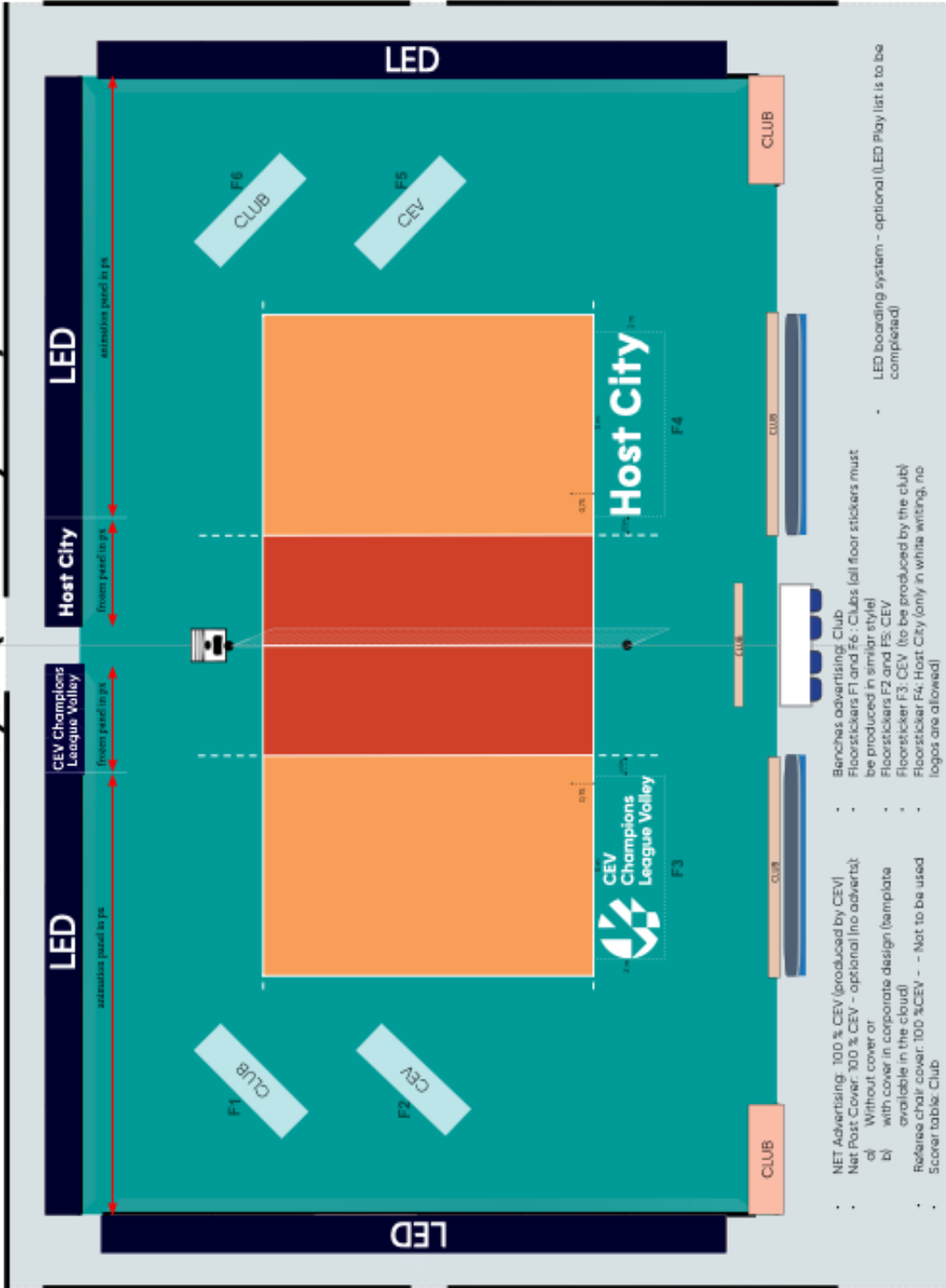


Court layout (LED) – Preliminary Round:

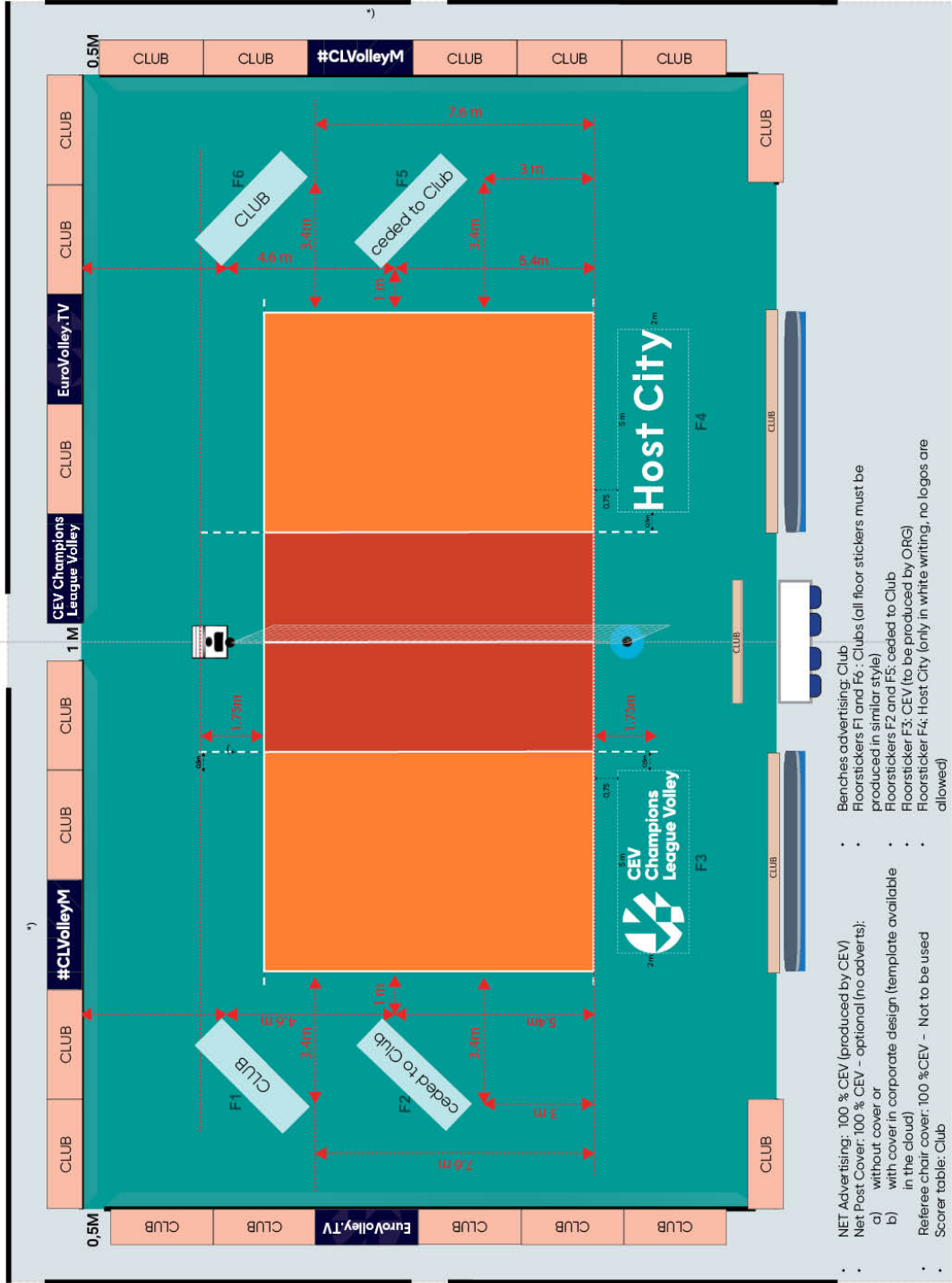


### Court layout (STATIC) – Rounds 1-3:

- Locker rooms scenes (recorded)
- Coin-toss (recorded)
- Post-match/flash interviews in English (live)

The participating clubs are requested to support on-site the appointed host broadcaster to perform the above-mentioned activities in a professional and timely manner including access to the team locker rooms, selection of players/coaches for the aforementioned activities and availability of the media officer to perform the different interviews in English.

## 8. Match Protocol & MVP

We would like to inform that the official match protocol is available on the CEV website under the following link:

We would like to remind that it is mandatory to award the MVP (Most Valuable Player) at the end of each match of the CEV Champions League Volley, the MVP of the match shall be awarded according to the above-mentioned match protocol and inserted accordingly in the e-Scoresheet. The hosting club shall produce a trophy to award the MVP.

## 9. FIVB Education Programme

With reference to the CEV Volleyball Competitions Regulations Article 83 §4:

*The Team manager shall present to the relevant CEV Official the following elements:*

*a. For each Team delegation member:*

- i. The FIVB Anti-Doping education programme certificate,*
- ii. The FIVB Competition Manipulation Course certificate,*
- iii. The accreditation card.*

In this regard, the FIVB has notified us that the VIS platform is ready to produce the relevant certificates. For those officials that do not have access to the VIS platform, the respective Federation of Origin shall proceed with their registration so that they can login and complete the above-mentioned online courses. We also would like to remind all teams that the provision of such certificates is mandatory to be eligible to take part in all CEV competitions, including the CEV Champions League Volley 2025.

Regarding the eligibility of the Players for the European Cups 2025, as the certificates are valid by the beginning of the competition, it is not necessary to complete the courses again after 1 January 2025.

## 10. CEV Accreditation System

It is mandatory to use the CEV Accreditation System for all CEV Volleyball European Cups matches.

You can access the accreditation system via [this link](#) or via the Club Area of the [CEV Database](#).

The clubs that already used the Accreditation System may continue using their old login. The clubs that are first time accessing the Accreditation System shall confirm the account upon logging in.

In case a club does not remember their credentials, you may create a new one by clicking "Forgot your password? Please click here to reset password"

Furthermore, there is a Badge Manager for the printing of the Badges for the home matches. Each club is responsible for printing the badges for their players and team officials for the entire season (excluding Final Four). In addition, the badge can be printed on the dashboard by downloading every badge separately.

The guidelines on how to navigate through the software are available within the documents area in the accreditation system.

## 11. CEV Service Operator Management

Please be reminded that every club has unique login credentials to run e-Scoresheet, Data Volley 4 and Video Sharing applications included in the [CEV Database](#) Club Area. The login credentials shall be shared with the appointed match operators. Each club is responsible for changing the login credentials if and where needed.

Please follow the steps outlined here below on how to manage the CEV Service Operator Management tool:

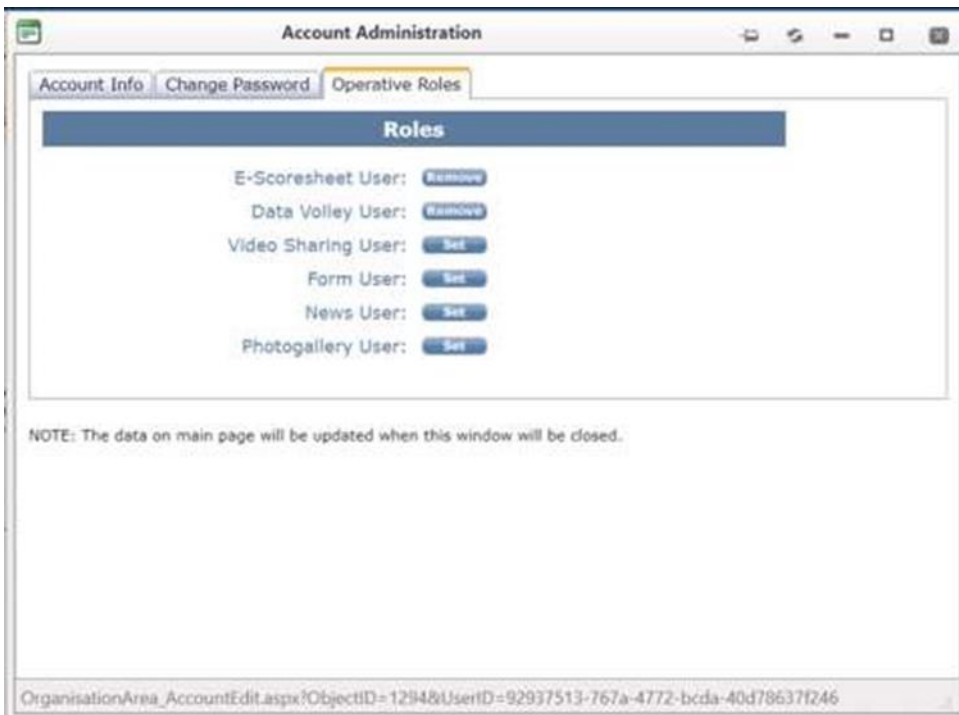

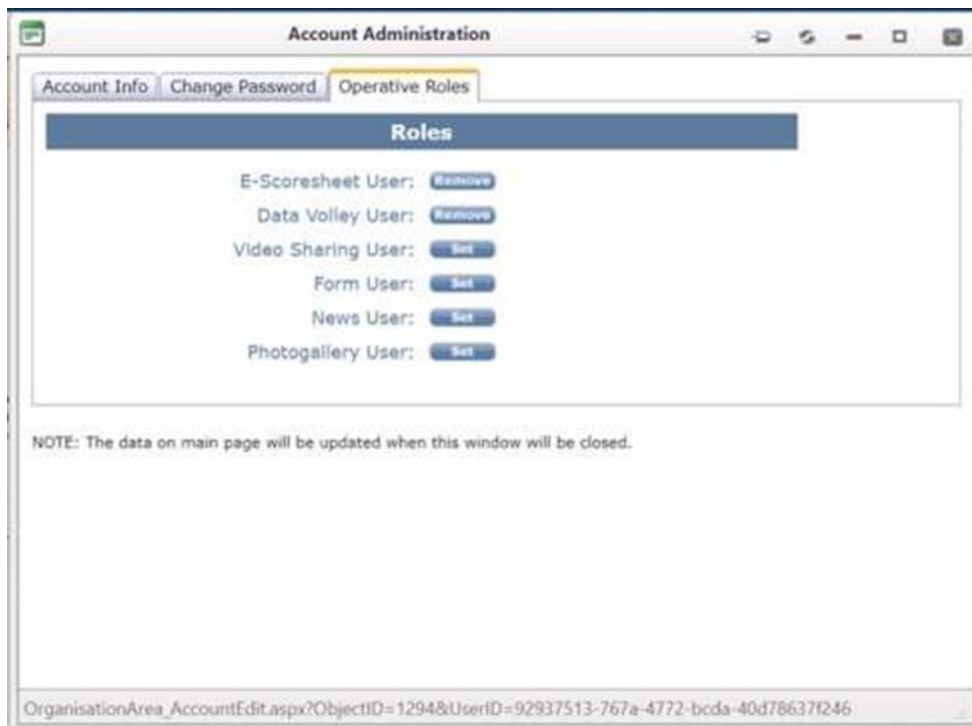

Following the announcement in the Official communication n°1 regarding a potential release of CEV reserved product categories by 30<sup>th</sup> September 2024, we would like to inform all teams participating in the CEV Champions League of the anticipated release of a number of product categories that have been reserved by CEV up to now.

The following categories are released, on a non-exclusive basis, for all phases, except the Final Four:

1. Airlines
2. Banking
3. Courier services & logistics
4. Body & healthcare products
5. Mobile phone/technology communications

Advertising is allowed on the set advertising spaces in the frame of the competition (e.g. court banners, LED system, print material, etc.)

The sponsors in the CLS forms already compiled have been approved accordingly.

The following categories are not released:

1. Betting and Gambling services
2. Sports Equipment - Volleyballs
3. Sportswear

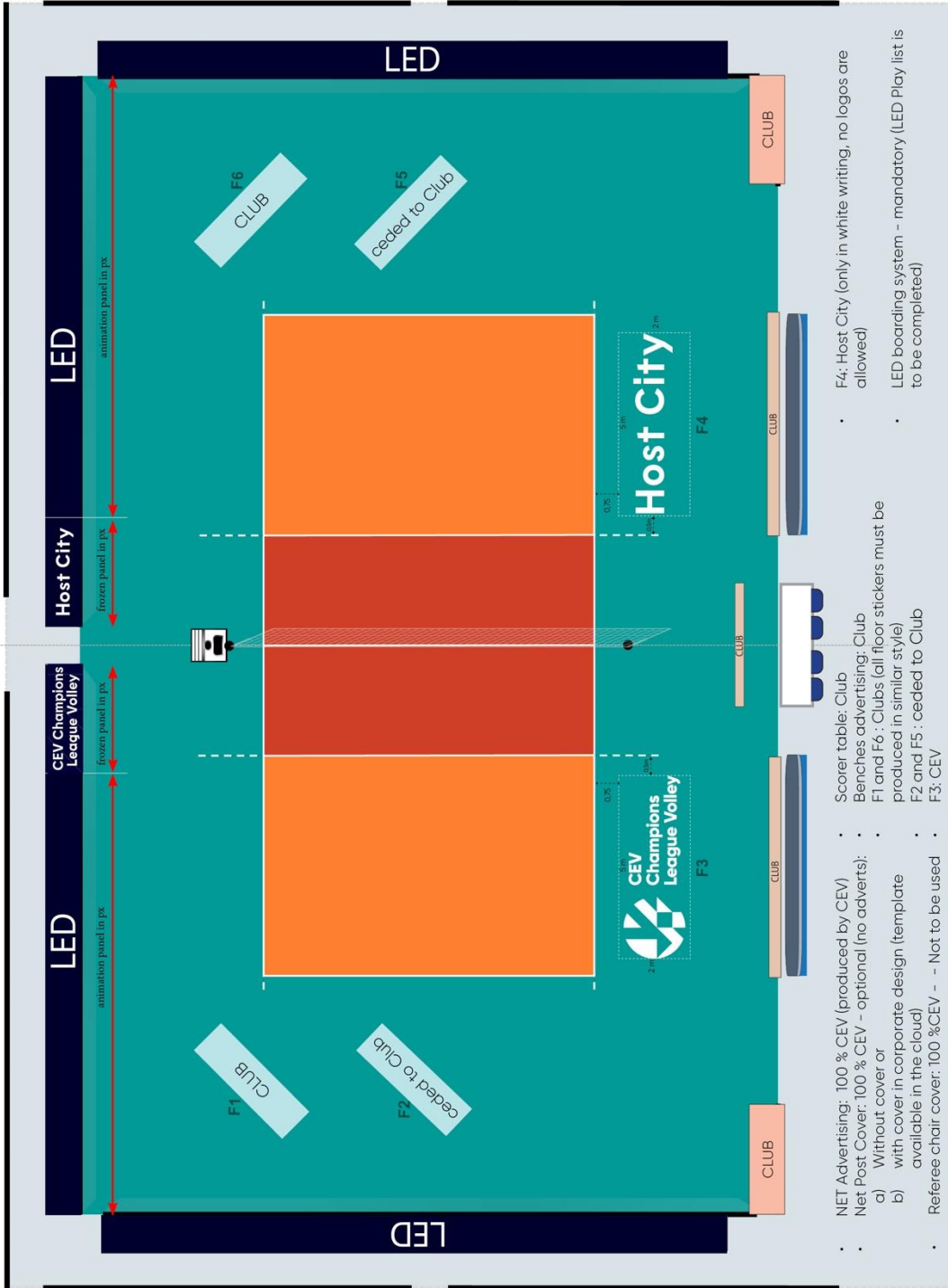
The decision has been made to add a bronze medal match to the previously announced competition format. The prize money allocation for the third and fourth place will be announced at a later stage.
