1. Introduction

Further to the latest changes to the international calendar adopted by the FIVB earlier this year, the next edition of CEV EuroVolley will be taking place in 2026 instead of 2025 as originally planned.

Participation will remain open to 24 teams per gender – including those representing the respective host countries (1 up to 4) and those qualified according to the final standing of the 2023 edition (minimum 8 up to a maximum of 11 depending on the number of host countries in each gender). The organisers and the exact competition dates for the CEV EuroVolley 2026 will be announced in due time.

The remaining National Federations will compete in one qualification round scheduled to be split and played in 2024 (3 Legs) and in 2025 (3 Legs) according to the CEV Board of Administration decision to qualify another 12 teams for the Final phase.

It remains the sole responsibility of the NFs registering for participation in the 2026 edition of CEV EuroVolley to respect all Communications, Regulations, Guidelines and institutional decisions to guarantee the delivery of correct, accurate and complete data at any time that these are required.

2. Registration procedure and deadline

The registration for this edition will be done through the CEV Database using the following form:

The registration deadline for closing and sending the above mentioned form is:

Monday, November 6, 2023, at 23:59 CET

After closing the form on-line, National Federations must click 'Print Form' and then sign, stamp the paper copy, and send it by registered letter to the CEV Office.

3. CEV EuroVolley 2026 Qualifiers format and dates

The teams representing the host countries and a minimum of 8 up to a maximum of 11 teams are directly qualified as per Art. 1 of this Official Communication. The remaining 12 spots to compete in the EuroVolley Final Round will be attributed as follows:

QUALIFICATION FORMAT

- Allocate registered teams not already qualified in groups of maximum 4 teams according to the European Ranking (serpentine system – 4 teams Berger Table).
- Play double round robin in single matches (home and away matches for each team).
- The best ranked teams across all pools according to the number of registered teams will qualify to the Final Round.

POOLS & EUROPEAN RANKING

The pool composition results from the latest CEV European Ranking for men's and women's national teams – as of November 6, 2023 – with teams being placed across the pools according to the serpentine system.

1.1 General provisions

National Federations not qualifying to further levels are eliminated from the CEV competition.

1.2 Qualification round

National Federations are allocated to pools consisting of three up to four teams. The 12 teams with the best result at the end of the qualifiers progress to the Final phase.

1.3 Final round

The Final round is organised with the 24 following National Federations:

- i. The teams representing the host country / host countries, directly qualified,
- ii. A minimum of eight and a maximum of 11 teams, depending on the number of host countries, as per the final standing of the 2023 edition.
- iii. 12 teams progressing from the qualifiers contested in 2024 and 2025.

The 24 participating teams are allocated equally in 4 Preliminary pools following a seeding and a Drawing of Lots based on the teams' position in the European Ranking as of August 18, 2025. The team(s) of the host country(ies) will be heading the pool that they are due to host. At the end of the pool stage, the four best placed from each pool qualify to the 1/8 finals.

In the 1/8 finals, the 8 winners qualify to the 1/4 finals.

In the 1/4 finals, the 4 winners qualify to the Semifinals.

In the Semifinals, the 2 winners qualify to the Gold Medal match and the 2 losers of the Semifinals will play the Bronze Medal match,

In the Gold Medal match, the winners are crowned the CEV EuroVolley 2026 champions.

5. Official Ball

However, the above release of the reserved categories is not applicable to the "Sport Equipment" and "Sportswear" categories.

*Advertisement of betting & gambling partners, whether direct or indirect, is not allowed in the frame of the competition unless the rights have been acquired from AMI (see below), except for advertising on player uniforms (jersey or shorts) on the positions foreseen as per the FIVB Events regulations.

Betting & gambling services sponsorship rights acquisition:

The CEV partner AMI, rightsholder of the "betting & gambling services" sponsorship rights worldwide, is offering the chance for participating National federations to acquire some rights for a National betting partner for the upcoming CEV EuroVolley 2026 qualifiers.

Match Production Obligation

National Federations shall produce their home matches as per the below minimum broadcasting requirements (standard B):

- World Feed signal is in HD 16:9
- Number of cameras: 6 HD cameras
- TV Signal delivery*: via satellite only (Eutelsat 7B or 10A carrier)
- Graphics: integration of the official CEV TV graphics package (to be provided by the CEV prior)
- Contact details: NF to provide to the CEV the contact details of their host broadcaster or local production company two weeks prior to the start of the competition.

*For the avoidance of any doubt, it is the responsibility of the appointed National Federation to provide to the CEV and the CEV Sport Media Agency <u>free-of-charge</u> a TV signal with DVB-S2 standard via an established European satellite such as Eutelsat 7B or Eutelsat 10A. A Eutelsat certified SNG HD fully redundant (1+1) capable of transmission DVB-S2 2 MPEG4/H.264 4:2:0 or 4:2:2 with BISS 1 Encryption.

The complete satellite parameters are to be provided in English to the CEV and CEV Sport Media Agency no later than seven days before the start of the relevant match.

CEV EuroVolley 2026

The CEV is not granting or licensing any Media Rights to the Co-Organiser in relation to the CEV Competition. Notwithstanding the above, the CEV will make available selected media rights on a non-exclusive basis (carve-out) to the National Federations for promotional purposes on their digital platforms.

9. Match Technology & Data Collection

CEV EuroVolley 2026 Qualifiers

The appointed National Federations have to respect the following requirements for each of their home matches during the CEV Competition:

- Compulsory use of the CEV data and statistics collection applications for each match including but not limited to E-scoresheet and DataVolley software to ensure a professional collection and distribution of data and statistics.
- For the avoidance of any doubt, the CEV will provide to the National Federations the necessary credentials (incl. username and password) to access the data and statistics collection applications prior to the event.

To ensure a professional usage of the above-mentioned applications, it is the responsibility of each National Federation to provide the below services, equipment, and resources free of charge to CEV for all matches of the CEV Competition:

- Download the <u>latest</u> software version <u>https://download.dataproject.com/cev</u>
- Necessary hardware to run adequately E-scoresheet application (such application is only available on Windows operating system).
- Necessary hardware to run DataVolley applications for statistics delivery.




- State-of-the art and dedicated high-speed internet connection as well as dedicated power supply.
- Testing of the application and connectivity one (1) week prior to their home matches in collaboration with CEV and its appointed official data provider.
- Hiring experienced human resources to operate E-scoresheet and Statistics software

7. Accreditation cards

It is mandatory to use the CEV Accreditation System for all CEV EuroVolley 2026 Qualifiers.

You can access the accreditation system via <u>this</u> link or via the National Federations Area of the CEV Database. Furthermore, there is a Badge Manager for the printing of the Badges for the matches. Each team is responsible for printing their badges for both home and away matches and they shall take such badges to their away matches as well, since those cards are valid for the entire qualification round.

The guidelines on how to navigate through the software are available within the documents area in the accreditation system.

8. Challenge System

According to the CEV Volleyball Competitions Regulations, the use of the Challenge System is **optional** for the CEV EuroVolley 2026 qualifiers.

In case the Challenge System is used:

- the hosting National Federation is requested to inform at the **latest by 01.07.2024** the CEV (<u>referee@cev.eu</u>) about which system will be used;
- the 2nd Referee appointed for a game will also officiate as a Challenge Referee for the same game.

9. Reserve Referee

For each of their home matches, the hosting National Federations will have to appoint one of their International Referees as a Reserve Referee. The Reserve Referee must be indicated in the respective Form 08 of the match inside the CEV Database.

10. Branding

The Graphics and Marketing Department works with the CEV Cloud.

The CEV Cloud is an optimised file-sharing and storage solution. All organisers have direct access to all resources via a web service interface. The CEV Cloud supports drag-and-drop file management.

No logins or passwords are needed.

However, all the relevant information and logos must be included in the design layout produced by the Organisers, namely the CEV logo, competition title and logo. The production of an official brochure / official programme is not mandatory.

UPLOAD FOLDER:

It includes all files to be uploaded, checked, and approved by CEV before production. The upload folder has a sub-folder for each National Federation: https://cloud.cev.eu/url/natteamsupl

All layouts and files (e.g. LED playlist, etc.) must be uploaded by the National Federations for final approval into their respective folder.

IMPORTANT:

The CEV Cloud does not automatically notify us of new file uploads. Therefore, organisers need to inform CEV (graphics@cev.eu and marketing@cev.eu) via a short email when uploading files for approval.

Match Production Obligation

National Federations shall produce their home matches as per the below minimum broadcasting requirements (standard B):

- World Feed signal is in HD 16:9
- Number of cameras: 6 HD cameras
- TV Signal delivery*: via satellite only (Eutelsat 7B or 10A carrier)
- Graphics: integration of the official CEV TV graphics package (to be provided by the CEV prior)
- Contact details: NF to provide to the CEV the contact details of their host broadcaster or local production company two weeks prior to the start of the competition.

*For the avoidance of any doubt, it is the responsibility of the appointed National Federation to provide to the CEV and the CEV Sport Media Agency <u>free-of-charge</u> a TV signal with DVB-S2 standard via an established European satellite such as Eutelsat 7B or Eutelsat 10A. A Eutelsat certified SNG HD fully redundant (1+1) capable of transmission DVB-S2 2 MPEG4/H.264 4:2:0 or 4:2:2 with BISS 1 Encryption.

The complete satellite parameters are to be provided in English to the CEV and CEV Sport Media Agency no later than seven days before the start of the relevant match.

12. Match Technology & Data Collection

CEV EuroVolley 2026 Qualifiers

For each match, the following match technology is provided and used by the participating National Federations for the CEV EuroVolley 2026 Qualifiers:

- a. The CEV E-scoresheet,
- b. The CEV Statistics (only Data Volley 4),
- c. Video Sharing,
- d. ES Referee & Bench applications.

Please find here below more information related to the usage of the CEV E-scoresheet, CEV Statistics and Video Sharing applications as indicated in the official Volleyball Competition Regulations:



- The E-scoresheet of a match is the only document which officially records the progress, results, participants, events, protests, and sanctions of such match. Statistics of each match are collected by designated match officials of the Organiser for CEV purposes.
- CEV is providing the necessary log-in credentials (including username & password) for the E-scoresheet, CEV Statistics and Video Sharing applications to the Organiser prior to the start of the CEV Competition.
- The Scorer shall complete the E-scoresheet and its printed version according to the Official Volleyball Rules and the Genius Sports application user guidelines.
- The Statistician shall complete the statistics file according to the Genius Sports application user guidelines.
- The Statistician shall upload the statistics and video files to Video Sharing according to the CEV Volleyball Competitions Regulations and the Genius Sports application user guidelines.
- The Organiser shall provide free-of-charge the following facilities and resources during the CEV Competition to operate the CEV E-scoresheet and CEV Statistics in a professional manner:
 - o Adequate hardware including laptop or tablet that is running the CEV E-scoresheet and CEV Statistics applications.
 - Ensure download and installation of the latest version of the CEV E-scoresheet and CEV Statistics applications.
 - o Ensure stable and high-speed internet connectivity and necessary power supply to ensure a professional data collection and distribution to CEV and CEV Commercial partners.
 - o Perform testing of the CEV E-scoresheet and CEV Statistics applications in the Competition Hall one (1) day before the start of each tournament.
 - o Ensure appointment of dedicated and experienced e-scorer as well as statisticians during the competition to collect data and statistics.
 - o For the CEV Statistics and CEV E-scoresheet, live match statistics shall be delivered throughout the match during the CEV Competition by connecting to the CEV Database, making use of the credentials provided by the CEV.
 - o The Organiser shall prohibit any illegal or non-authorised collection, archiving and distribution of match-related data and statistics during the live matches of the competition.




13. Court Layouts







 - The best four classified teams from Pool A and C play against each other. Same goes for Pool B and D, as follows:






- The 1/4 finals
 - o The winners of the 1/8 finals qualify to the 1/4 finals.
 - Men: The 1/4 Finals will be played in two host countries in Italy and Bulgaria between the two winners of the 1/8 Finals that were played in the same country.
 - o Women: The 1/4 Finals will be played in two host countries in Türkiye and Czechia between the two winners of the 1/8 Finals that were played in the same country.
- The Semifinals
 - o The winners of the 1/4 finals In the Semifinals.
 - o The matches will play in Türkiye for Women and Italy for Men
- The Final
 - o The 2 winners of the Semifinals qualify to the Gold Medal match while the 2 losers of the Semifinals will play for the Bronze Medal match
 - o The Finals will be played in Türkiye for Women and in Italy for Men's competition.
