**2. Purpose of the Declaration**

This Declaration is established in the framework of the 2026 CEV Beach Volley European Cup (hereinafter, the “CEV Competition”).

The purpose of this document is to confirm and regulate the participation of the Player in the CEV Competition with the Club under the Receiving Federation, with the acknowledgement and support of the National Federation of Origin.

**3. Acknowledgment by the National Federation of Origin**

The National Federation of Origin hereby:

- Confirms that the Player is currently registered with its Federation.

- Acknowledges and approves the Player's intention to register with the Club affiliated to the Receiving Federation for the purpose of participating in the CEV Competition.
- Authorises the Player to obtain the necessary license/registration with the Receiving Federation in accordance with applicable regulations.
- Supports the Player's participation in the CEV Competition under the Club.

#### **4. Player Commitments**

The Player hereby declares and commits to:

- Comply with all applicable CEV and FIVB Beach Volleyball Regulations, as well as the rules of the Receiving Federation and the Club.
- Ensure that all personal registration, licensing, and eligibility requirements are fulfilled accurately and in a timely manner.
- Honour all sporting and contractual obligations undertaken with the Club for the duration of the CEV Competition.
- Maintain professional conduct and uphold the integrity, image, and values of the CEV Competition.
- Ensure availability for participation in the CEV Competition, subject to health, eligibility, and regulatory conditions.
- Promptly inform the National Federation of Origin, the Receiving Federation, and the Club of any circumstance that may affect participation or eligibility.

#### **5. Receiving Club Commitments**

The Club hereby declares and commits to:

- Register the Player in full compliance with CEV and FIVB Beach Volleyball Regulations and under the framework of the Receiving Federation.
- Ensure that the Player is duly licensed and eligible to participate in the CEV Competition.
- Assume responsibility for the Player's participation in the competition, including organisational, logistical, and sporting matters.
- Respect all applicable rules governing international player transfers and maintain cooperation with the National Federation of Origin.
- Ensure that the Player benefits from appropriate insurance coverage, medical support, and safeguarding measures during participation.
- Respect applicable regulations regarding player release for national team duties, where relevant.
- Uphold the integrity, values, and sporting principles of the CEV Competition.

**6. Receiving Federation Commitments**

The Receiving Federation hereby:

- Confirms that the Player is registered by receiving club in full compliance with CEV and FIVB Beach Volleyball Regulations.
- Acknowledges and approves the Player's intention to register with the Club affiliated to the Receiving Federation for the purpose of participating in the CEV Competition.
- Authorises the Player to obtain the necessary license/registration in accordance with applicable regulations.
- Supports the Player's participation in the CEV Competition under the Club.

**7. Joint Declaration**

The National Federation of Origin, the Player, the Club and the receiving National Federation jointly acknowledge and agree that:

- This document constitutes a mutual recognition of the Player's participation in the CEV Competition under the Receiving Federation.
- All parties will cooperate in good faith to ensure compliance with applicable regulations and the smooth execution of the Player's participation.
- Any matters not expressly covered in this Declaration shall be governed by the applicable CEV and FIVB regulations.
- Any dispute arising in connection with this Declaration shall be handled in accordance with the relevant CEV and FIVB regulatory framework.

**8. Final Provisions**

This Declaration enters into force upon signature by all parties and remains valid for the duration of the Player's participation in the 2026 CEV Beach Volley European Cup.
