#### 1.1. Date and Venue

The CEV Beach Volley European Cup Final 2025 will be hosted for both genders at Ammoudara Beach, Candia Maris, Heraklion, Greece.

The event will take place from the 06<sup>th</sup> to the 09<sup>th</sup> of November 2025, as per announcement on CEV's website (link).

- Be duly registered in the Volleyball Information System (VIS) and meet the FIVB/CEV eligibility criteria
- Provide the <u>letter of Support from the National Federation of Origin form</u>, in case registered in the VIS by a different National Federation to the one the Club is affiliated though the respective form available here CEV website

- Submit the Players' Commitment & Health Certificate form as per the CEV instructions
- Have completed both the FIVB "Play Clean" anti-doping course as well as the FIVB elearning course on the Prevention of Competition Manipulation

Only athletes not suspended by CEV and/or FIVB are allowed to participate in the competition. Each athlete may represent only one (1) Club per European Cup season.



Each athlete will be eligible to compete if they appear in the long list of athletes that clubs have submitted by September 16<sup>th</sup> 2025.

All qualified Clubs are required to submit their travel schedule through the BV04. This document must be uploaded on the Cloud link all Clubs have been provided with.

#### 1.4. Withdrawal

Should a Club withdraw from the CEV Beach Volley European Cup, financial sanctions will be applied in accordance with the CEV Beach Volleyball Competition Regulations and Guidelines.

In case spots to the Final become available due to last minute withdrawal(s), the spot(s) will be allocated to the respective Preliminary Phase pool runner-up as per Official Communication n.4. Should the spot earned by the best second placed club in the preliminary phase according to the BV European Cup Country ranking become available due to withdrawal, this will be assigned to the next best second placed club in the preliminary phase, following the same ranking.

The participating Clubs will be seeded in the competition as per the CEV European Beach Volley Cup NF ranking available on the CEV Website <a href="here">here</a>.



# 3. Competition update

# 3.1. Pool allocation Preliminary Phase

As outlined in Official Communication <u>No. 1</u>, participating Clubs are allocated to the respective pools based on a) seeding according to the CEV Beach Volley European Cup Country Ranking that you can find <u>here</u>, and b) geographical criteria.

More specifically:

- Clubs from the top 6 countries in the CEV Beach Volley European Cup Country Ranking have been placed as pool leaders,
- Clubs from the following 6 countries have been placed as 2<sup>nd</sup> to pool, apart from those organising a pool, which were moved to the next possible spot (pools without an organiser) and considering geographical proximity
- In case multiple NFs shared the same ranking, the one with the best result in the 2024 edition was ranked higher
- In case multiple clubs shared the same ranking and same result in 2024, alphabetical order was applied to determine the position. This is according to CEV standards applied also for international Volleyball competitions
- Clubs from the same country were not positioned in the same pool. They were moved to the next available spot.

For clubs representing a National Federation without a country ranking in this competition, a draw was conducted on September 8<sup>th</sup> 2025, taking into consideration also geographical proximity. In such cases, countries were divided into three groups, Western, Central, and Eastern Europe, to ensure alignment with the criteria set in the competition Official Communication. Clubs from the same NFs were not allowed to be in the same pool.

# 3.2. Preliminary Inquiry and schedule

The Preliminary Inquiry across all pools will take place the Friday evening before the start of the competition from 19:00 (local time). All delegations must be present at the Preliminary Inquiry, presenting their playing uniforms and ID documentation.

# 3.3. Competition format Preliminary Phase

The competition format will be a club vs club double header format in a round robin system played over two (2) competition days. No Golden Set will be played in case of a tie after completion of the club vs club double header.

For Pools of 4 and 5 Clubs a single round robin system will be applied, while for pools of 3 Clubs a double round robin system will be applied (each Club facing the other 2 Clubs in the pool twice).

Wins and losses per match will be counted as follows:

- 2 points for the winning club of a match
- 1 point for the losing club of a match
- 0 points for the club that forfeits a match

In case of a tie in match points at the end of the pool, the tie will be broken according to the principles laid down in the <u>CEV Beach Volleyball Guidelines</u> 3.4 (Tie in a pool play competition method).

Seven clubs will be qualifying from the Preliminary Phase to the Final of the CEV Beach Volley European Cup, which will take place in Heraklion (GRE), from the 6<sup>th</sup> to the 9<sup>th</sup> of November 2025. The seven clubs will qualify as follows:

- Winners of the six pools will qualify directly.
- The seventh qualified team will be the best second place club according to the CEV Beach Volley European Cup Country Ranking. Should all the second places across all pool come from NFs that are not currently ranked, or two or more NFs share the same ranking a draw will be performed in the CEV Office, during a live public streaming.



In case spots to the Final become available due to last minute withdrawal(s), the spot(s) will be allocated to the respective Preliminary Phase pool runner-up.

- Match 7: club seeded #2 vs club seeded #4
- Match 8: club seeded #1 vs club seeded #3
- Match 9: club seeded #4 vs club seeded #5
- Match 10: club seeded #1 vs club seeded #2

#### Pools of four (4) National Federations:

- Match 1: club seeded #2 vs club seeded #3
- Match 2: club seeded #1 vs club seeded #4
- Match 3: club seeded #2 vs club seeded #4
- Match 4: club seeded #1 vs club seeded #3

All teams should plan for a full day of competition on both Saturday and Sunday, irrespective of their pool allocation.



Seven clubs will be qualifying from the Preliminary Phase to the Final of the CEV Beach Volley European Cup, which will take place in Heraklion (GRE), from the 6<sup>th</sup> to the 9<sup>th</sup> of November 2025. The seven clubs will qualify as follows:

- Winners of the six pools will qualify directly.
- The seventh qualified team will be the best second place club according to the CEV Beach Volley European Cup Country Ranking. Should all the second places across all pool come from NFs that are not currently ranked, or two or more NFs share the same ranking a draw will be performed in the CEV Office, during a live public streaming.



In case spots to the Final become available due to last minute withdrawal(s), the spot(s) will be allocated to the respective Preliminary Phase pool runner-up.

In case of a tie in match points at the end of the pool, the tie will be broken according to the principles laid down in the <u>CEV Beach Volleyball Guidelines</u> 3.4 (Tie in a pool play competition method).

Seven clubs will be qualifying from the Preliminary Phase to the Final of the CEV Beach Volley European Cup, which will take place in Heraklion (GRE), from the 6<sup>th</sup> to the 9<sup>th</sup> of November 2025. The seven clubs will qualify as follows:

- Winners of the six pools will qualify directly.
- The seventh qualified team will be the best second place club according to the CEV Beach Volley European Cup Country Ranking. Should all the second places across all pool come from NFs that are not currently ranked, or two or more NFs share the same ranking a draw will be performed in the CEV Office, during a live public streaming.

In case spots to the Final become available due to last minute withdrawal(s), the spot(s) will be allocated to the respective Preliminary Phase pool runner-up.

#### 3.4. Order of the club vs club double header

The round robin format will be played as follows:

#### Pools of five (5) Clubs:

- Match 1: club seeded #2 vs club seeded #5
- Match 2: club seeded #3 vs club seeded #4
- Match 3: club seeded #1 vs club seeded #5
- Match 4: club seeded #2 vs club seeded #4
- Match 5: club seeded #1 vs club seeded #4
- Match 6: club seeded #2 vs club seeded #3
- Match 7: club seeded #1 vs club seeded #3
- Match 8: club seeded #4 vs club seeded #5
- Match 9: club seeded #1 vs club seeded #2
- Match 10: club seeded #3 vs club seeded #5

#### Pools of four (4) National Federations:

- Match 1: club seeded #2 vs club seeded #3
- Match 2: club seeded #1 vs club seeded #4
- Match 3: club seeded #2 vs club seeded #4
- Match 4: club seeded #1 vs club seeded #3
- Match 5: club seeded #3 vs club seeded #4
- Match 6: club seeded #1 vs club seeded #2

#### Pools of three (3) National Federations (repeated twice, see Art. 3.3):

- Match 1: club seeded #2 vs club seeded #3
- Match 2: club seeded #1 vs club seeded #3
- Match 3: club seeded #1 vs club seeded #2

All teams should plan for a full day of competition on both Saturday and Sunday, irrespective of their pool allocation.

# 3.5. Seeding within the pool

The seeding of the participating clubs within the pool will be according to the result of the drawing of lots annexed to this document.

# 3.6. Rights of participation

As communicated in the Official Communication n.1, any athletes wishing to participate in the CEV Beach Volley European Cup must fully comply with the following requirements:

- Confirm in writing their commitment to representing the respective Club through the <u>CEV Beach Volley European Cup Athlete's Commitment Form</u>
- Be duly registered in the Volleyball Information System (VIS) and meet the FIVB/CEV eligibility criteria
- Provide the <u>letter of Support from the National Federation of Origin form</u>, in case registered in the VIS by a different National Federation to the one the Club is affiliated
- Submit the Players' Commitment & Health Certificate form as per the CEV instructions
- Have completed both the FIVB "Play Clean" anti-doping course as well as the FIVB elearning course on the Prevention of Competition Manipulation



Only athletes not suspended by CEV and/or FIVB are allowed to participate in the competition. <u>Each athlete may represent only one (1) Club per European Cup season.</u>

Clubs must submit the long list of athletes through the <u>Registration of Athletes form, by September 15<sup>th</sup> 2025.</u>

#### 3.7. Withdrawal

Should a Club withdraw from the CEV Beach Volley European Cup, financial sanctions will be applied in accordance with the CEV Beach Volleyball Competition Regulations and Guidelines.

#### 3.8. Athlete's Uniforms & Accessories

As already indicated in Official Communication n.1, each participating Club is responsible for providing all delegations members with uniforms, including the athletes' tops/jerseys. Extensive marketing exploitation of the uniforms with exposure of up to 4 sponsors/supporters remains with the Club. Please refer to the layouts in Official Communication n.1.

In addition, each participating Beach Volley Club retains the right of displaying a Title Sponsor in the official Club's name used for the entire competition.

# 1. Qualification process – Update

As per the qualification process pathways communicated through the CEV Beach Volley European Cup Official Communication No. 1, the following Zonal Associations and National Federations have homologated their Beach Volley Clubs competitions (in alphabetical order):

The CEV Beach Volley European Cup Final 2025 will be hosted for both genders at Ammoudara Beach, Candia Maris, Heraklion, Greece. The event will take place the period between October 30<sup>th</sup> and November 9<sup>th</sup> (exact dates to be announced at a subsequent Official Communication)

# 3. Competition update

## 3.1. <u>Clubs' registration</u>

All Bech Volleyball Clubs who gain the right and wish to participate in the CEV Beach Volley European Cup 2025, need to be registered by the respective National Federation by September 4<sup>th</sup>, 2025 through the relevant Registration Application form, to be sent to beachclubs@cev.eu.

The registration of the roster representing each Club is due <u>by September 15<sup>th</sup> 2025</u>, through the <u>Registration of Athletes form</u>, to be uploaded on the respective folder of the CEV Cloud. To participate in the competition all athletes must be listed in this form, change of players or late registrations will not be permitted for the duration of the competition (both Preliminary Phase and Final).

All necessary documents for the participation of an athlete as listed in Article 3.4 of this document <u>and will have to be uploaded on the CEV Cloud prior to their participation in the competition</u> (both Preliminary Phase and Final),

CEV will provide a personalised and individual link to all National Federations and Clubs after receiving their Registration Application form.

### 3.2. <u>Preliminary Phase</u>

The CEV Beach Volley European Cup Preliminary Phase will be played in a tournament format with all qualified and registered Clubs as per the registration deadline, conditions and documentation provided in Articles 1.3, 2.1 and 2.2 of the CEV Beach Volley European Cup Official Communication No 1.



The Candidature Application guidelines for the Preliminary Phase tournaments are available on the CEV website here: 2025 | CEV.

Each tournament will be played in a Club vs Club double header format and will consist of a Round Robin pool play where each Club plays each other in 2 matches. Each match is allocating two (2) points to the winning and one (1) point to the losing Club team. Zero (0) points are allocated in case a team forfeits a match.

Each Beach Volleyball Club participates with 2 teams and a delegation of minimum 4 and maximum 6 athletes, plus minimum 1 coach / head of delegation as detailed in Article 2.1 of the CEV Beach Volley European Cup Official Communication No1.

Each Club is entitled to 1 substitution per match (an athlete may leave the game and re-enter the court only once, and only to the same athlete, out of the 2 potential substitutes registered in the scoresheet).

An athlete who has participated as a substitute in the 1<sup>st</sup> match of the double header cannot participate as a substitute in the 2<sup>nd</sup> match.

No substitution is allowed in case a Club is participating in the competition with only four athletes.

An update over the number of Preliminary Phase tournaments and dates/locations will be shared following the clubs registration and the candidature application deadlines through a subsequent Official Communication.

#### 3.3. Final 2025

The CEV Beach Volley European Cup Final 2025 will be played with eight (8) Clubs per gender. The breakdown of the eight (8) Clubs is as follows:

- Organiser Spot Registered Club from Greece
- Seven (7) Clubs qualifying from the Preliminary Phase as detailed in Article 2.1 of the CEV Beach Volley European Cup Official Communication No 1.

Each Beach Volleyball Club participates with 2 teams and a delegation of minimum 4, maximum 6 athletes, plus minimum 1 coach and a head of delegation as detailed in Article 2.1 of the CEV Beach Volley European Cup Official Communication No1.

The Final will be played in a Club vs Club double header format and will consist of two phases:

- A pool play phase in Round Robin format where each Club plays each other in 2 matches, with each match allocating 2 points to the winning and 1 point to the losing Club
- A single elimination final phase where each Club plays each other in 2 matches. In case of a tie after two matches, the 3<sup>rd</sup> and deciding match will be played as a Golden Set to 15 points right after the 2 matches. For the Golden Set, each Club must field a pair made up of a new combination of athletes who have not played together in either of the previous two matches. This pair can include players from the earlier matches or athletes who have not yet competed in the double header. No substitution will be allowed in the Golden Set.

Each Club is entitled to 1 substitution per match (an athlete may leave the fame and re-enter the court only once, and only to the same athlete, out of the 2 potential substitutes registered in the scoresheet). An athlete who has participated as a substitute in the 1st match of the double header cannot participate as a substitute in the 2nd match. No substitution is allowed in case a Club is participating in the competition with only four athletes or in case of a Golden Set.

## 3.4. Player's Rights of participation

As indicated in Official Communication No. 1, section 2.2, any athletes wishing to take part in the CEV Beach Volley European Cup must fully comply with the following requirements (links have been updated):

- Confirm in writing their commitment to representing the respective Club through the CEV Beach Volley European Cup Commitment Form
- Be duly registered in the Volleyball Information System (VIS) and meet the FIVB/CEV eligibility criteria
- Provide the <u>letter of Support from the National Federation of Origin form</u>, in case registered in the VIS by a different National Federation to the one the Club is affiliated
- Upload the <u>Players' Health Certificate</u> on their VIS Profile
- Have completed both the FIVB "Play Clean" anti-doping course as well as the FIVB elearning course on the Prevention of Competition Manipulation

Only athletes not suspended by CEV and/or FIVB are allowed to participate in the competition. Each athlete may represent only one (1) Club per European Cup season.

## 3.5. <u>Clubs' registration</u>

All Clubs who have the right and wish to participate in the Beach Volley European Cup, need to be registered by the respective National Federation by September 4<sup>th</sup>, 2025 through the relevant Registration Application form, to be sent to beachclubs@cev.eu.

The registration of the roster representing the Clubs is due by September 15<sup>th</sup> 2025, through the Registration of Athletes form, to be uploaded on the CEV Cloud.

## Introduction

The **CEV Beach Volley European Cup** is the latest addition to the CEV Beach Volleyball portfolio. Through its introduction in 2023 the competition aims at incorporation Beach Volleyball Clubs in the CEV Beach Volleyball ecosystem, in close collaboration with National Federations and other stakeholders.

Following the very successful two previous editions organised in 2023 in Balikesir, Türkiye, and in 2024 in Montpellier, France, the CEV is now launching the 2025 edition. The CEV Beach Volley European Cup 2025 is planned for the last quarter of 2025, following completion of the qualification process as detailed below.

Men's and Women's competitions will run separately from each other. The 2025 edition of the Beach Volley European Cup will consist of 2 phases: a Preliminary Phase (number to be confirmed at a later stage) and a Final tournament, featuring 8 clubs per gender.

## 1. Qualification Process

## 1.1. Zonal Event qualification pathway

Each Zonal Association is entitled to host one qualifying event towards the Beach Volley European Cup. The Zonal Association Club Championship winner obtains the right to compete in the CEV Beach Volley European Cup.

The homologation of the qualifying Zonal Event needs to happen by May 30<sup>th</sup> 2025, by submitting the Zonal Beach Volleyball Clubs Competition Homologation form. This form contains the relevant organising terms and conditions to host such competition. This event must be concluded by July 13<sup>th</sup> 2025.

## 1.2. <u>National Championship qualification pathway</u>

As per the previous editions, each National Federation in entitled to host one or multiple events to qualify Beach Volleyball Clubs to the CEV Beach Volley European Cup.

National Federations with an already existing or planned National Clubs competition shall define and communicate to the CEV the respective information (number of events, process of clubs registration, number of participating clubs etc.) by April 30<sup>th</sup>, 2025, through the respective National Clubs competition Homologation Form.

The National Beach Volleyball Club competition needs to be concluded by August 31st, 2025, at the latest.

The winner of the National Clubs competition obtain the right to compete in the CEV Beach Volley European Cup 2025. In addition, a 2<sup>nd</sup> spot is allocated to the 2<sup>nd</sup> ranked Clubs from the top 4 National Federations in the 2025 CEV Beach Volleyball NF Ranking.

If a Club wins both the Zonal Association Club Championship and its respective National Club competition, the qualification from the Zonal Association Championship will be prioritised. The vacant spot from the National Clubs competition will be granted to the next eligible Club.

#### 1.3. <u>European Cup Final organiser's spot</u>

The organiser of the Final may be a National Federtaion or a Clubs will be confirmed through a Candidature Application process at a later stage and will be granted a spot to the Final.

In case the organiser is the National Federation, the winning Club of the respective National Federation will earn this spot provided that the National Clubs Championship is duly homologated.



In case the organiser is a Club, this will automatically earn the right to participate in the European Cup Final, provided that:

- √ The NF supports the Candidature Application to host the event
- √ The Club participates in their respective homologated National Clubs competition Should the same Club win also the National Championship, the right to participate to the European Cup will be allocated to the next best ranked Club in the National competition.

All qualified Clubs having the right and wish to participate in the Beach Volley European Cup need to be registered by the respective National Federation by September 4<sup>th</sup>, 2025 through the relevant <u>Registration Application form</u>, while the registration of the athletes due to represent the Clubs is due by September 15<sup>th</sup>, 2025 through the <u>Registration of Athletes form</u> (see Article 2.2).

# 2. Competition Parameters

#### 2.1. Competition format

The 2025 edition of the Beach Volley European Cup will consist of 2 phases: a Preliminary Phase and a Final tournament, featuring 8 clubs per gender.

The spots will be allocated as follows:

- In case of up to 7 Club registrations, all Clubs qualify directly to the Final
- In case of more than 7 registrations, the spots to the Final will be allocated through a preliminary phase that will involve all registered Clubs. The preliminary phase will be completed between the following two weekends:
  - o 27<sup>th</sup> and 28<sup>th</sup> September 2025
  - o 4<sup>th</sup> and 5<sup>th</sup> October 2025

The competition is played in a Club vs Club format where each Beach Volleyball Club participates with 2 teams and a delegation of minimum 4 and maximum 6 athletes, plus minimum 1 coach and a head of delegation.

The preliminary phase will be organised in pools, considering the number of homologated National events and registered club, seeding and geographical criteria and will be detailed in subsequent Official Communications.

Each participating National Federation/Club has the right to apply for the organisation of the Preliminary Phase tournaments. A document detailing the organising conditions will be shared to all NFs/Clubs concerned and will follow the principles applied in the Final in regard to the CEV support and participating Clubs' obligations, yet lower organisational conditions for the organising NF/Beach Volleyball Club will be required.

In case of insufficient number of organisers for the Preliminary Phase these tournaments will be drawn amongst the registered Beach Volleyball Clubs.

## 2.2. <u>Right of Participation</u>

Any athletes wishing to take part in the CEV Beach Volley European Cup must fully comply with the following requirements:

- Confirm in writing their commitment to representing the respective Club through the <u>CEV Beach Volley European Cup Commitment Form</u>
- Be duly registered in the Volleyball Information System (VIS) and meet the FIVB/CEV eligibility criteria
- Provide the <u>letter of Support from the National Federation of Origin form</u>, in case registered in the VIS by a different National Federation to the one the Club is affiliated



- Submit the Players' Commitment & Health Certificate form as per the CEV instructions
- Have completed both the FIVB "Play Clean" anti-doping course as well as the FIVB elearning course on the Prevention of Competition Manipulation

Only athletes not suspended by CEV and/or FIVB are allowed to participate in the competition. <u>Each athlete may represent only one (1) Club per European Cup season.</u>

## 2.3. <u>CEV Beach Volley European Cup NF Ranking</u>

The CEV Beach Volley Cup NF ranking reflects the results of each past edition and they current standing of participating National Federations.

Ranking points are allocated to all clubs participating in the CEV Beach Volley European Cup, including those participating in the preliminary phase, and are retained over a period of three years with a percentage of 60% for the points resulting from the most recent edition of the competition, 30% for those from the event held a year earlier and 10% for the remaining edition included in this three-year period

The ranking follows the below scale and will be used for the seeding of Clubs representing their respective NF. The seeding of additional Clubs from the same NF will follow the seeding of all NF champions as per the principle applied in the CEV Volleyball Clubs competitions.

<sup>\*</sup> The ranking points for those clubs not qualifying to the Final are based on the number of total registrations and the competition format of the preliminary phase tournaments.

#### 2.4. Prize money

A Prize Money of 15,000 EUR will be allocated in the Beach Volley European Cup Final tournament to the top four ranked Beach Volleyball Clubs per gender, as per the following breakdown:

Rank	Prize money (per Club)
1	7,500 €
2	4,000 €
3	2,500 €
4	1,000 €

No prize Money is allocated for the preliminary phase tournaments.

#### 2.5. Rules of the Game

All matches shall be played according to the FIVB Official Beach Volleyball rules in their latest edition.

**Exception:** The presence of a coach inside the field of play is allowed provided that this coach is duly accredited as per the relevant provisions and timeline. The obligations and rights of



coaches entering the field of play as well as their uniform layout are detailed in the CEV Coaching Regulations document.

#### 2.6. Athletes' Uniforms & Accessories

Each participating Club is responsible for providing all delegations members with uniforms, including the athletes' tops/jerseys. Extensive marketing exploitation of the uniforms with exposure of up to 4 sponsors/supporters remains with the Club and as per the annexed layouts.

In addition, each participating Beach Volley Club retains the right of displaying a Title Sponsor in the official Club's name used for the entire competition.

#### 2.7. <u>Transportation, Board and Lodging</u>

All participating Clubs are responsible for their travel, board and lodging expenses.

# 3. Financial Regulations

#### 3.1. <u>Participation Fee</u>

To participate in the CEV Beach Volley European Cup, the respective Club shall pay a once off participation fee of 200,- EUR to the CEV through their respective National Federation.

#### 3.2. License Fee

For each athlete participating in the CEV Beach Volley European Cup, each Club shall pay a once off license fee upon receipt of the respective CEV invoice and through the respective National Federation, as defined in the CEV Beach Volleyball Competitions Regulations.

# 4. Further Information

All necessary information about the competition will be circulated to National Federations by using the Official Communications and the relevant Practical Info documents.

Additional information concerning the competition and the registered teams will be published on the CEV Beach Volley European Cup competition section of the CEV website.





# **ANNEX: ATHLETES UNIFORMS LAYOUT**





A Club may present less than 2 sponsors on each side of the top or the same sponsor on both the front and back sides. For the shorts/bottoms, any sponsors' appearance shall follow the provisions of the CEV Beach Volleyball Guidelines.

Each Club needs to prepare 2 sets of uniforms (tank tops and shorts/bottoms) in different colours numbered from 1 to 6
